Note: Following consideration of the above mentioned items if the Committee is still concerned about the decisions and according to the Council's Constitution, (Para 20(d) of the Call-in rules), the Scrutiny Committee may then either ask the Individual Lead Cabinet Member to reconsider his decision (setting out the reasons for its concern) or may refer the matter to the full Council.

On receipt of the response from the Scrutiny Committee the individual Lead Member may decide to proceed with the original decision or make an amended decision. That is his decision. If the Committee decides to take the latter course, the Council can either not object to the decision or object to the decision and refer the matter back to the Lead Member for re-consideration. In that case, the Council can express views to the Individual Lead Member, but cannot alter the decisions.
