1. Financial Appraisal

2. Background and Supporting Information

- 2.1 The Departmental Policy Steers are currently being reviewed as part of the Reconciling Policy and Resources process and the White Paper 'Our health, Our care, Our say' which sets out the national strategic direction for Adult Social Care. The 2006/07 Adult Social Care policy steers are attached at **Appendix A**.
- 2.2 Adult Social Care would like to propose two changes to the policy steers, for consideration by the Scrutiny Committee:
 - 1) Remove 'increase access to intermediate care and rehabilitation services that promote independence'. It is proposed that this policy steer is deleted as these areas of service provision are captured under two other policy steers namely:
 - With Health and Housing improve how we plan and commission services
 - Support more older people and vulnerable adults in their own homes and local community.
 - 2) Replace 'develop disability and mental health services which focus on community support, ensuring effective transition from children's services' with 'support young people transferring from children's to adult social care services'. The revised wording ensures that this policy steer covers all areas of service provision, not just disability and mental health.

3. Conclusion and Reasons for Recommendation

3.1 The proposed changes ensure that the resulting <u>2007/08</u> policy steers (**Appendix B**) capture all of the priority areas for improvement identified within the Adult Social Care Three Year Plan and other relevant planning documentation.
