Title of report: Thornwood Intermediate Care Services

Purpose of report: To inform the Scrutiny Committee on progress in

respect of arrangements for Thornwood Intermediate

Care Services.

RECOMMENDATION(S)

The Adult Social Care Scrutiny Committee is recommended to:

1. Consider and comment on the progress to date in arrangements for Thornwood Intermediate Care Services (TICS)

1. Financial Appraisal

1.1 The Contractual Arrangements between Rother Homes and East Sussex County Council have come to an end to achieve closure of the services on the following dates: -

Thornwood Intermediate Care (Residential) 31st August 2007 Thornwood Day Services 31st August 2007

The County Council will pay a maximum payment of £578,000, which comprises the following elements.

- In respect of running costs for the Residential and Day Services for the 2007/08 financial year (1st April 2007 to 31st August 2007) up to £278,000 including the annual uplift.
- For all legally payable redundancy and pension augmentation costs associated with the closure up to a maximum of £300,000.

2. Background Information

- 2.1 TICS was established in February 2004 and commissioned through a Pooled Budget arrangement with Hastings and Rother Primary Care Trust.
- 2.2 The Cabinet considered a report by the Director of Adult Social Care on 30th January 2007 and agreed to negotiate with Rother Homes and Hastings and Rother Primary Care Trust to terminate the contractual arrangements for the provision of Intermediate Care Services.
- 2.3 Cabinet approved the investment in community based services and the opportunity to adjust the balance of provision from residential to community based services.

3. Current Position

- 3.1 In reviewing the current services, the Project Team have consulted widely taking into account views and comments as well as considering current and future care needs.
- 3.2 The closure of Thornwood Intermediate Care Services by Rother Homes was completed on 31st August 2007. The last residential service users left Thornwood Intermediate Care Services by the second week in August 2007 and this service element is now closed. These services had been used primarily to provide a rehabilitative service for hospital discharge and have now been re-provided in the Independent Sector as well as beds being utilised at the Irvine Unit. To date there has been no significant increase in delayed transfers of care at the Conquest Hospital.
- 3.3 Day Services at Thornwood closed on 31st August 2007.

A part time project worker has been appointed to facilitate a smooth transfer of services from Thornwood to alternative services.

Almost all service users are transferring to alternative in-house day services at the following:

Isobel Blackman Centre Moreton Day Centre Pinehill Charter Centre

In addition, there have been a small number of referrals to the Independent Sector where appropriate. Please see attached Appendix for details.

Appendix 1 - Thornwood Day Care – closing 31 August 2007

All service users at Thornwood Day Care have been reviewed and have been offered alternative services.

All service users eligible for day care from East Sussex County Council Adult Social Care have been accommodated in Directly Provided Services as summarised in Table 1. They have already started their attendance at the new centres.

Other Thornwood service users have had information given by the Reviewing staff

and have been offered help and support in accessing new services.
