RECOMMENDATIONS

The Committee is recommended to note the contents of the final ASC Action Plan report in response to the Scrutiny Review of the Provision of Preventative Services

1. Financial information

1.1 A range of services with a preventative focus have been funded between 2007 and 2009. To highlight several:

Local Area Agreement (LAA) spend on preventative services

- 1) County Connect simple checklist and interagency referral system Annual Cost £20,000 (the first year (July 07 June 08) was funded 6 months Anchor Staying Put & 6 months POPP). The LAA has funded the rest (July 08 March 09) approximately £15,000. Also a grant of £1820 was received from ES Fire & Rescue Service to be spent on publicity.
- 2) Community Falls Response Service Total cost for January 2007 June 2008 £96,600 for staff costs, plus another £8000 for project evaluation. Additional £715 spent on Leaflets & Posters for the local falls prevention services with another duplicate order just arranged. Care Home Intervention and associated falls prevention equipment for ASC, PCT's and associated partners (Age Concern etc) £30,000 allocated, to be spent by end of March 2009.

Telecare

2006/07 - £231,934 Actual, 2007/08 - £233,763 Actual, 2008/09 - £463,940 forecast of Non-Care Managed element = £50,208.

<u>Grant Funded Services provided by the Voluntary/Community Sector</u> 2008/09 – Total ASC spend = £5,720,270 + Other ESCC funding £116,600

Social Care Reform Grant (from the DH to support wide transformation of social care) Aspects of this spend will support preventative activity, including the Joint Information & Access project to improve health and social care information and access for residents and staff. The grant total is £5.2m over three years to 2010/11.

2. Background and Supporting Information

- 2.1 In mid-2007, the ASC Scrutiny Board undertook a review of preventative services and ASC subsequently prepared an Action Plan to respond to the recommendations. This is the final report on the activity outlined in the ASC Action Plan. The Action Plan itself, including completed progress updates, is appended.
- 2.2 ASC responses to the Scrutiny Review recommendations are summarised as follows: Reducing the need for intensive services is supported in the Department of Health concordat of Putting People First and coupled with our ESCC Policy Steers, retains strong emphasis in ASC. Developments for East Sussex have included sustaining the Partnerships for Older People

Projects (POPP) programme and utilising local and national evidence in wider work, rolling out telecare, embedding simple access to low-level equipment in the emergent Improving Life Chances Joint Commissioning Strategy and improving data capture for the Grant Funded Services return to better understand and reflect the non-care managed services supported by ESCC.

- 2.3 <u>External funding</u> has been received from a number of sources, the greatest being the Social Care Reform Grant (SCRG) from the DH. Funds have been received from the local PCTs for several jointly-managed projects. An external funding officer has been recruited recently and is now supporting ASC and partners in sourcing of external grants.
- 2.4 <u>Working practices and expenditure levels by partners</u> has been monitored through the GFS return and the Local Area Agreement. The establishment of 6 steering groups to support implementation of the Older People's Joint Commissioning strategy is proving effective. Successful projects include developing Forward from 50 and development of information packs for hospital patients being discharged.
- 2.5 <u>The Older People's Services Interdepartmental Working Group</u> have been meeting on a quarterly basis and actively performance managing the Time of Our Lives Action Plan. Networking and co-ordination of improving universal services has been in evidence.
- 2.6 Outcomes of implementing the Joint Commissioning Strategy for Older People include a clear governance structure. Targets relating to all aspects of the care pathway are monitored robustly and opportunities for preventative work are encompassed at each stage.
- 2.7 Effectiveness of STAN (Single Telephone Access Number) service
 In February 2006 the 'STAN' service was set up by Brighton and Hove City PCT (BHCPCT) and the East Sussex PCTs (Hastings and Rother and East Sussex Downs and Weald PCTs). Its purpose was:
 - To provide a one stop shop for healthcare professionals and to reduce the number of admissions and attendances to medical assessment units across NHS ESDW, NHS H&R and BHCPCT
 - To facilitate the provision of more services closer to people's homes and a more patient focused service
 - To generate robust activity data to inform commissioning intentions
- 2.8 An initial evaluation was conducted by South Coast Audit in November 2007 and has contributed to the ongoing development of the service. The pilot has been extended a number of times with the intention of putting it out to competitive tender in 2009/2010.

3. Conclusion

3.1 The Scrutiny Board's review of preventative services has provided helpful direction and impetus to the department's work in this important and complex area. CSCI's recent finding that ASC's preventative services (for older people) were good, is external recognition of achievement in this arena. The Department's Action Plan in response to the recommendations has been completed and details of progress are appended for approval by the Board.
