Title of report: Update report on the progress towards developing a new model for the

Integrated Community Equipment Service

Purpose of report: To inform the scrutiny committee of the proposed service model for ICES

RECOMMENDATION

The Committee is recommended to consider and comment on the proposed service model for the integrated community equipment service

1. Financial Appraisal

1.1. There is no overall increase in costs within the proposed service model but an anticipated shift of resources from logistics to 'community equipment'. This will allow more equipment to be supplied to more people thus improving the efficiency and flexibility of the service and enabling increasing demand to be met from the same level of funding.

2. Background and Supporting Information

- 2.1 The Integrated Community Equipment Service is critical to supporting people to remain at home and has a vital role in supporting numerous **care pathways** which enable people to remain or return home. Over the period Jan to December 2010, the service processed over 30,000 orders, delivering over 65,000 items of equipment. The majority of activity relates to simple aids of equipment (70%) of which 83% are low cost items. The service is funded through a Section 75 Pooled Budget (£3.5 million) with East Sussex Downs and Weald PCT and Hastings and Rother PCT.
- 2.2 The current service provider is Nottingham Rehabilitation Supplies (NRS). The contract is due to expire on 30th September 2011. A formal notice was placed in the Official Journal for the European Community in November 2011 setting out our intentions to tender for the provision of a community equipment service and minor adaptation service. The tender timetable is presented in Appendix One. The contract will be awarded in May 2011.
- 2.3 Demand for community equipment is predicted to increase due to the demographic profile of East Sussex and health and social care policies to support people stay in their homes.
- 2.4 The current service model is focused on a **single contractor** responsible for adults and children and is composed of the following elements: procurement; catalogue management, storage; delivery & demonstration; fitting (putting in place); installation (attaching grab rails, mopstick rails etc); collection; decontamination, replacement and repair and maintenance of electro-mechanical equipment. This is a total service solution with all equipment delivered and collected irrespective of its **value** or **re-usability**.
- 2.5 In addition, the contractor also directly carries out **minor adaptations** or **sub-contracts** non-standard works to two main sub-contractors (Ghyllside and Metcalfe).
- 2.6 Re-commissioning the **current service model** could present financial risks if demand continues to increase as is projected. The committee are requested to note the following:
- Including all the current elements of equipment provision and minor adaptations within one service, does not allow supported housing and third sector organisations to compete.
- A total service solution for all equipment irrespective of cost or re-usability is not efficient. The current service model is 'over engineered' with too much emphasis on 'logistics';
- The need to shift the distribution of costs from 'logistics' to 'equipment'.
- Adult social care currently commissions services within the third sector that can meet need as and
 provide value added services. This was tested in a successful pilot project for the provision of
 sensory aids and equipment.

- The provision of paediatric equipment is best provided on a regional basis due to the low volume and specialist nature of the equipment.
- 2.7 The Adult Social Care Scrutiny Committee commissioned a review in 2008 to examine the options available for the future provision of the service when the current contract ended in September 2009. Following the decision to extend the current contract until September 2011, the review amended its remit and instead monitored how the department was moving forward with developing a new model of provision. The review ended last year and the board identified a number of recommendations:
- Report back on the timescales for re-commissioning ICES. The tender timetable is provided in Appendix One;
- Clarification about installations of grab rails. Service users will not be required to install grab
 rails as they are not regarded as 'simple aid'. All grab rails will be installed as part of the minor
 adaptation service.
- Clarification about what checks will be carried out if service users fit their own equipment.
 Where service users have agreed to arrange for the delivery and fitting of simple aids, the
 practitioner will contact the service user to ensure that the equipment has been delivered and
 correctly fitted.
- Expanding the pilot project for the provision of sensory aids and equipment. Provision of sensory aids and equipment will be provided by the third sector through the commissioning prospectus. The commissioning prospectus was launched in February 2011 setting our commissioning intentions. All funding agreements with the voluntary sector will be awarded in July 2011. The timetable is presented in Appendix Two.
- 2.6 The service model being taken forward includes the following elements:
- Tendering for a community equipment service and minor adaptation service, allowing new service
 providers to bid for the minor adaptation service whilst also allowing established providers to bid
 for the entire service. The tender timetable is presented in Appendix One.
- Shifting the focus of service provision to **cost effectiveness** in preference to 'response times'. The business requirements to be met by service providers include:
 - o an web based order management system to enable prescribers to place, track, amend and cancel orders;
 - o Service user led processes to ensure orders are fulfilled on the first visit
 - o Simpler scheduling to allow the service provider to use optimise operational capacity
 - Fitting and demonstrating simple aids for daily living where the prescriber has identified a need:
 - Collecting simple aids for daily living only where they can be re-used.
- Commissioning the provision of sensory aids and equipment through the third sector commissioning prospectus which was launched on 21st February 2011. Successful providers will be awarded funding agreements in July 2011. The prospectus timetable is presented in Appendix Two.
- Separation of the provision of 'paediatric' equipment from the core service. Childrens therapy services are taking forward the provision of paediatric equipment separately in line with their business requirements as part of a regional procurement process led by the Strategic Health Authority.

3. Conclusion and Reasons for Recommendation

3.1. The committee is recommended to support the revised service model in order that the service can meet projected demand in the most cost effective way.
