 - The Council has maintained its accreditation under the Investors in People standard.
 - A new series of health and Safety e-learning programmes have been launched.
 - 21 applications have been received for Recession Fund projects, of which 12 have been successful. £482,916 has been committed with an expected cash match funding of £382,915 and in-kind match funding of £19,000.

2.3 Portfolio for Corporate Resources

- A Virtual School was launched to monitor education progress of all Looked After Children.
- The 2 year implementation programme of connecting up all large corporate sites, all schools and most libraries to the next generation network (NGN) was completed.
- Council services have moved to the cheaper 0345 telephone numbers, and schools now have high capacity broadband.
