- **4.** QUARTERLY MONITORING REPORT (APRIL TO JUNE 2001 AND BEST VALUE PERFORMANCE PLAN 2001/2002
- 4.1 The Committee considered a report by the Chief Executive, to which were attached the Balanced Performance Management Tables relating to Education Department targets in the Best Value Performance Plan for the quarter April to June 2001.
