## 2. <u>MINUTES OF LAST MEETING</u>

- 2.1 RESOLVED to confirm as a correct record the minutes of the meeting of the Committee held on 23 April 2003, subject to:
- 2.2 (I) the addition of Councillor McPherson's apologies for absence:
- (ii) the addition to paragraph 39.8 of the words " given that the scoping review carried out by the former Community Services Scrutiny Committee had concluded that a review should be held in abeyance until the People's Network had been in place for a reasonable time, and given that the newly-appointed officer responsible for the library service was not yet in post"; and
- (iii) the addition to paragraph 33.1 of the words "which indicated that the content of this Committee's minutes would be a matter for discussion by the Director of Legal and Community Services and the Chairman."

## 4. DISCLOSURES OF INTEREST

- 4.1 Councillor Barnes declared a potential non-prejudicial interest in item 8 below by virtue of his being Chairman of the Bexhill and Rother Primary Care Trust.
- 4.2 Councillor Mrs Waite declared a non-prejudicial interest in item 9 below by virtue of her being a member of the Chartered Institute of Librarians and Information Professionals.

### 5. NOTIFICATION OF URGENT MATTERS

- 5.1 The Chairman informed the Committee that he proposed to take as an urgent item of business a request to scrutinise the consultation exercise currently being undertaken in Hastings and Rother concerning provision for post-16 education, ie whether this should be provided through sixth forms or a sixth form tertiary college. He considered that the matter warranted the urgent attention of the Committee because the consultation was already in progress and any decision to scrutinise the process would need to be acted upon before the next scheduled meeting of the Committee.
- 5.2 The Chairman referred to a letter he had received from Councillor Mrs Waite expressing concern about the way in which the consultation was being carried out, in view of local concerns that decisions had already been taken about post-16 education in Hastings and Rother before the consultation had been properly concluded.
- 5.3 The Director of Education's representative informed the Committee that the consultation had currently reached the third stage of a seven stage process. The consultation was being led by the Learning and Skills Council; the local education authority had the status of a partner in this exercise. He suggested that the Committee would need to consider the most appropriate way to scrutinise a process which was outside the direct jurisdiction of the local education authority.
- 5.4 RESOLVED to (1) give notice to the Cabinet of the Scrutiny Committee's intention to undertake some form of scrutiny of the process by which the current consultation on post-16 education provision in Hastings and Rother is being carried out;
- (2) appoint a group of members of the Committee, comprising Mr Taylor, Mrs Maynard and one councillor-member (to be decided), to undertake the scrutiny;
- (3) request the Director of Education to provide the above group of members with further information about the consultation and the local education authority's role in it to enable the group of members to consider the most appropriate scrutiny method; and
- (4) invite representatives of the Learning and Skills Council to attend the next meeting of the Scrutiny Committee on 17 September.

(3) request the Director of Education to circulate to members of the Scrutiny Committee for information extracts from the Education Development Plan concerning actions to improve pupil attainment at Key Stage 2.
