1. Background of the review

- 1.1 The Children's Services scrutiny committee decided at its June 2006 meeting to hold a scrutiny review around the services provided by the Youth Offending Team (YOT).
- 1.2 It was recognised that the review board will not have sufficient time to look in depth at all the areas of work within the YOT. It was suggested by members at the June meeting that the review might wish to concentrate on the role of the Youth Offending Team in crime prevention and the value of multi agency working.
- 1.3 Following consultation with officers in the YOT it is clear that crime prevention is an important issue at present and one that is receiving focus at a national and local level. In particular the East Sussex Youth Justice Plan will be prioritising targeted youth crime prevention work during 2006/07. The Council Plan also has as one of the goals for 2006/07 to prevent offending by children and young people.

2. Proposed scope and terms of reference

2.1 Aim of the review:

To establish how effective the work of the Youth Offending Team has been with regard to youth crime prevention and in what way has the multi agency nature of the YOT helped with this.

- 2.2 The review will examine the YOT's strategy and work in relation to youth crime prevention, in particular:
 - The role of youth crime prevention workers
 - Funding provided to other agencies to co-ordinate the provision of youth crime prevention work
 - The use of restorative justice to address anti-social behaviour and offending by children and young people
- 2.3 The review will examine the effectiveness of multi agency working in crime prevention, in particular:
 - Seconded members to the YOT from partner agencies
 - YOTs working relationship with the police and judicial system
 - YOTs links to the Crime and Disorder Reduction Partnerships
 - Inter-departmental working relationships

3. Methods

3.1 **Documentation and research:**

- East Sussex Youth Justice Plan 2006-2007
- Council Plan and performance indicators

- Benchmarking information to compare the YOT in East Sussex with other similar authorities
- Audit Commission review of the reformed youth justice system (2004)
