## 32. VIEWING OF DVD: 'SUPPORTING LITERACY IN THE HOME'

- 32.1 The Panel viewed a DVD called 'Supporting literacy in the home'. The DVD explained the stages of reading for children and how carers can take the necessary steps to help children become better readers.
- 32.2 RESOLVED to (1) request an update at a future Panel meeting on the impact and success following the launch of the DVD; and

(2) request that copies of the DVD be distributed to members of the Corporate Parenting Panel when they become available.

## 33. LOOKED AFTER CHILDREN STATISTICS

33.1 The Panel noted that the statistics on children placed for adoption had increased in October and November and agreed the drop in figures earlier in the year probably resulted from the implementation of the new Adoption and Children Act in December 2005. The trend on placements with agency foster-carers had gone slightly downwards and this exemplifies the progress made in developing the in house service.

- 33.2 The Panel also noted that the number of looked after children had gone up by 19 in the past year. This increase had been absorbed by the increase in the number of in-house foster carers. The Deputy Director for Children and Families advised the Panel that these increases had put a pressure on the fostering budget and an additional £600,000 has been allocated in 2007/8 to deal with this.
