# 14. EAST SUSSEX FOSTER CARERS' ASSOCIATION

14.1 The Panel received a presentation on the work of the East Sussex Foster Carers' Association (ESFCA) by Ben Vince, Tina Henderson and Marnie Clarke.

14.2 The presentation focussed on the work and achievements of the East Sussex Foster Carers' Association over the past year and these included:

- Receiving lottery funding which has allowed them to employ 2 part time workers. ESFCA raised in excess of £100,000 (£48,000 for lottery and £52,000 from other funders) last year that went directly into services for looked after children, children who care, and foster carers.
- Core work which included a very successful annual conference; Christmas parties; computers for children in care; newsletters; quiz nights; 2-day residential trip to Little Canada for children who foster; luggage for looked after children; and social days out.

- Survey was undertaken about the effect that the new integrated service had impacted on looked after children (results attached).
- User groups for children and young people who foster
- Inspiration Project
- 2-day 'Healing Parents Conference'
- Monthly surgeries for foster carers, to give them access to Senior Managers from Children's Services
- Embarking on a new 'CV and Suits' project to support care leavers gain further education or employment
- Keynote speakers at the Fostering Network annual conference
- Congratulations to Ann and Denis Holder who received an MBE

14.3 The Panel were asked to consider a tabled paper requesting the provision of a centre from which to run their services for children in care, children who care and foster parent.

### 15. <u>REPORT ON THE EDUCATIONAL ATTAINMENT OF LOOKED AFTER CHILDREN</u> IN THE SCHOOL YEAR 2006-07

15.1 The Panel considered a report by the Director of Children's Services informing them of the educational outcomes of looked after children in 2007 and the strategies used in order to continue to raise attainment in East Sussex.

#### 18. LOOKED AFTER CHILDREN STATISTICS

- 18.1 The Panel noted:
  - The number of placements with in-house foster carers had gone up whilst the number placed with agency foster carers was on a downward trend.

- The number of children placed for adoption was also on a downward trend and the Deputy Director Children and Families explained more research was needed to fully understand the reason why.
- A reduction in the number of children placed in 'other residential' accommodation whilst the number of children placed in 'ESCC residential' homes had increased.
- A reduction in the number of children placed with a parent.

# 19. DRAFT ANNUAL REPORT ON CORPORATE PARENTING

19.1 The Panel considered the draft annual report prepared by the Director of Children's Services.

19.2 The Panel received a tabled paper of an extract from the Joint Area Review report detailing the results of the inspection of the Looked After Children service.

19.3 The Panel discussed possible future topics to be bought to the Panel; these included mental health issues; housing for care leavers; and public health issues.

(3) expand the conclusion to include the areas of improvement and recommendations detailed in the Joint Area Review inspection report.
