REPORT OF THE GOVERNANCE COMMITTEE

The Governance Committee met on 3 May 2010.

1. Review of Proper Officer Appointments

1.1 In March 2011, the Governance Committee agreed to authorise the Chief Executive to consult with staff on a number of changes to the senior officer structure of the Council. Following the consultation period, the management of the Registration Service transferred to the Assistant Director of Community Services on 11 April 2011. The County Council is required to make formal appointments to a number of Proper Officer positions. To reflect the change in management responsibility the list of Proper Officers appointments should be amended as follows:

1.2 The Committee recommends the County Council:

to agree to the Assistant Director of Community Services post being designated as the Proper Officer for Registration matters as set out above.

2. Proposed Changes to Scrutiny Committees

- 2.1 The rationalisation of departments following the review by the Chief Executive is currently being implemented. This includes a transfer of the functions relating to economic development, travellers and trading standards from Governance and Community Services to the renamed Economy, Transport and Environment Department. The Adult Social Care Department has assumed responsibility for Community Safety.
- 2.2 As a consequence of these changes, the scrutiny arrangements have been reviewed and the Committee is recommending the transfer of some scrutiny functions between committees to reflect the revised management arrangements set out below. The proposed terms of references are set out in Appendix 1 which has been circulated separately to all members.
- (1) Scrutiny of travellers, trading standards and economic development transfers to a re-named Economy, Transport and Environment Scrutiny Committee;
- (2) Community safety transfers to a renamed Adult Social Care and Community Safety Scrutiny Committee which would take on the statutory community safety scrutiny function.
- 2.3 The workloads of the scrutiny committees have been reviewed and the recent introduction of a 'callover' process in Audit and Best Value Scrutiny Committee has enabled routine items to be dealt with more efficiently. It has been concluded that with these changes, the Community Services Scrutiny committee is no longer viable. The Governance Committee is therefore recommending to delete this committee and transfer its remaining activities (e-government, community planning, libraries, the arts, registrars and archives and voluntary sector) to a renamed Audit, Best Value and Community Services Scrutiny Committee.
- 2.4 One less scrutiny committee would result in a committee management efficiencies from four fewer formal meetings per year. Resources (mainly staff time, printing, postage etc) would be saved or diverted to undertaking more scrutiny projects resulting from increased workloads and remits of the other committees. There would also be a saving resulting from the reduction of the special responsibility allowance for one scrutiny chairman.
- 2.5 When reducing the number of scrutiny committees, consideration will need to be given to Part 4 of the Constitution (Rules of Procedure) which provides that "Chairmen and Vice-Chairmen of scrutiny committees are allocated to the political groups in proportion to the number of seats they have on the Council. Within this allocation, the chairman of the Audit, Best Value

[and Community Services] Scrutiny Committee is appointed from the largest political group not represented on the Cabinet".

- 2.6 The proposed reduction in the number of Scrutiny Committees also has a wider impact on the allocation of places on committees as set out in Appendix 2 to the report (circulated separately to all members).
- 2.7 The Committee **recommends** the County Council to

 - 2) agree to the revised terms of reference of the scrutiny committees as set out in Appendix 1;
 - 3) allocate to political groups the places on, and membership of, the main committees as set out in Appendix 2; and
 - 4) delegate to the Assistant Director, Legal and Democratic, authority to make any necessary changes to the Constitution to give effect to these decisions.

APPENDIX 2

Allocation of Places on Committees: Political Balance Provisions

- 1. In allocating places on ordinary committees the Council is required to follow the principles set out below unless it agrees (with no member voting against) that the political proportionality rules shall not apply:
 - (a) the first principle to apply is that not all of the seats on the body can be allocated to the same political group;
 - (b) the second principle to apply is that where more than half the members of the Council belong to one political group, that group shall have a majority on all committees, sub-committees, etc;
 - (c) subject to (a) and (b) above, the third principle to apply is that the total number of seats on the ordinary committees (including sub-committees) allocated to a political group reflects that group's proportion of the members of the Council;
 - (d) subject to (a) to (c) above, the fourth principle to apply is that the number of seats on each body allocated to a political group reflects the proportion of the seats on the Council held by the group.
- 2. The total number of seats allocated, on the assumption that one scrutiny committee of seven members is removed, would be as follows:
