WRITTEN QUESTION PURSUANT TO STANDING ORDER 44

1. Question by Councillor Whetstone to Councillor Maynard, Lead Member for Transport and Environment

How many Petitions were received by the County Council in the last financial year? How many of these were for the Transport and Environment department? How many of these were for traffic control schemes, how much did it cost the department to respond to these and how many produced an answer favourable to the petitioners?

Answer by Councillor Maynard

There were 19 petitions presented to the Chairman of the County Council in the last financial year. 17 of the petitions were for the Transport and Environment department of which 16 related to traffic control schemes.

It is difficult to say how much it costs the department to respond to a petition as each response time is variable, depending on the petition, and the costs relate to officer time, rather than additional costs to the department. Thus we can not give the cost to the department without a significant information gathering exercise requiring a substantial amount of officer time.

Out of the 16 petitions, 4 produced a favourable response to the petitioners. Of the remaining 12, 2 produced an unfavourable response, 1 is still to be reported to Lead Member and 9 are ongoing due to various factors, including needing further investigation, changes to assessment processes and so on.

2. Question by Councillor Tutt to Councillor Elkin, Lead Member for Adults and Children's Services

Please would the lead member provide details of the latest code of practice on consultation for schools considering opting out of LEA control? Would they also confirm whether all East Sussex schools considering such a change are following this consultation programme?

Answer by Councillor Elkin

As Councillor Tutt will be aware, the Council does not have a preferred position regarding the legal status of schools. The policy approved by the Lead Member in November 2010 however stated that the Council does "strongly believe that schools should consult their students, staff, parents, and community effectively before taking any decisions about the status of the school."

This is the approach that we have explained to schools and that we have followed when we have responded to consultations.

If a school wishes to convert to academy status, and so 'opt out' of LA control, it must comply with the requirements of the Academies Act 2010. Clause 5 of the Act requires the Governing Body to "consult such persons as they think appropriate" before the implementation date of the conversion, although this consultation "may take place before or after an Academy order, or an application for an Academy order, has been made". The consultation should be on the question of whether the school should convert to an academy.

These statutory requirements are therefore very light, and the Council's policy position outlined above is, rightly, more onerous. We certainly believe that schools need to engage in open and honest consultation that provides sufficient time and adequate information to enable people to respond effectively. In that sense, we envisage schools adopting processes similar to those required for maintained schools in terms of breadth of stakeholders and the period for consultation.

The decision regarding whether a school should convert to academy status is for the Governors of the school (and the Diocese for appropriate schools). The Council is not in a position to necessarily know which schools are considering such a move, and so cannot confirm what approach to consultation they would take. Councillor Tutt can be assured however that the Council will be pushing for academy consultations to follow the principles I outlined.
