43. Chairman's Business

AWARD FROM PERSONNEL TODAY

43.1 On behalf of the Council the Chairman congratulated the Personnel and Training team which won a prestigious national award from Personnel Today – the HR industry publication. The team won the inaugural award for Innovation in Dispute Resolution for its work in establishing a workplace mediation service and helping individuals and teams to resolve disputes quickly and fairly. The Service, which has been developed in partnership with Trade Union colleagues, sees trained and accredited mediators work both within the Council and with external organisations to resolve workplace disputes before they develop into grievances. Since introducing the service the number of workplace disputes has fallen by 47% and our mediators have so far successfully resolved more than 150 cases without further intervention being required, achieving significant productivity savings in the process.

EAST SUSSEX MUSIC SERVICE

43.2 The Chairman stated that was good to see councillors attending the events organised by the East Sussex Music Service. He reminded all members that the Music Service is in the middle of its Christmas season and encouraged all members to attend the Service's events in their area. The

Chairman stated that he could highly recommend the events and would encourage other Members to support the Service.
