#### 52. Chairman's Business

#### **NEW YEAR'S HONOURS**

52.1 On behalf of the Council the Chairman congratulated all who worked or lived in East Sussex who had been recognised in the New Year's Honours. In particular, the Chairman congratulated Councillor Bob Tidy who had been awarded an MBE for services to local government and the community, to Hilary Lane who retired in 2011 from the post of the Council's Cultural Strategy Manager and who was awarded an MBE, and Des Prichard (Chief Fire Officer and Chief Executive of the East Sussex Fire and Rescue Service) who was awarded an OBE.

## 55. Reports

#### **CALLOVER**

55.1 The Chairman of the County Council, having called over the reports set out in the agenda, reserved the following paragraphs for discussion:

#### NON-RESERVED PARAGRAPHS

55.2 On the motion of the Chairman of the County Council, the Council ADOPTED those paragraphs in the reports of the Committees that had not been reserved for discussion.

#### 56. CABINET REPORT – RECONCILING POLICY AND RESOURCES

- 56.1 Under Standing Order 23, the Council agreed that the speeches of the Leaders of the four groups (or their nominees) on paragraph 1 of the Cabinet's report should be extended beyond five minutes.
- 56.2 The following amendment was moved by Councillor Tutt and seconded was LOST:

Replace paragraphs 1.7 (1) and 1.7 (3) of the Cabinet's report with the following:

- (1) Approve, subject to(1) (i) to (1) (iv) below, the Capital Programme in relation to schemes in progress or about to start and those to start in 2012/13 and 2013/14 and to note the schemes provisionally included in the capital Programme in future years as set out in Annex 5 of Appendix 1;
- (i) commence roll out of 20 mph speed limits outside schools (£500,000)
- (ii) provide additional finding of programme of permanent repairs to pot holes (£1,000,000)
- (iii) provide further resources for Footway Maintenance (£500,000)
- (iv) fund the above one off additions with a reduction in the Council unearmarked general balances (£2,000,000)

- (3) approve, subject to (3) (i) to (3) (ix) below, the revenue budget estimates for 2012/13 as set out in Annex 3 (a) of the commentary on the Revenue Budget circulated to all members (Appendix 2);
- (i) Reduce planned savings for older people arising out of the "Redefining the service offer" action within Adult Social Care assuming a better understanding of high impact customer changes (£150,000 p.a.)
- (ii) Reduce planned savings for Working Age Adults arising out of the "Redefining the Service Offer" actions within Adult Social Care assuming a better understanding of high impact customer changes (£550,000 p.a.)
- (iii) Limit the maximum increase on implementation of Fairer contributions within Adult Social Care to £20 per week; recognising that only a very broad estimate of the resultant cost is possible pending specific income assessment experience (£200,000 p.a.)
- (iv) Continue the previous support to families with children in receipt of after school support activities; within the Disability Service areas of the Children Services proposals (£350,000 p.a.)
- (v) Reduce the impact of proposed changes in supported Bus Services within Economy, Transport and Environment (£75,000 p.a.)
- (vi) Recruit an additional post for Travel Planning to support further community traffic initiatives within Economy, Transport and Environment (£40,000 p.a.)
- (vii) Limit the proposed reduction in Rights of Way Maintenance and staffing within Economy, Transport and Environment (£100,000 p.a.)
- (viii) Extend the reach of youth support with the Children's Services area (£500,000 p.a.)
- (ix) Finance the above total resultant cost of £1.965m p.a. by:
  - Reduce the amount spent on publication and paper documents across the Council by £120,000 p.a.
  - Reduce the amount spent on external venues across the Council by £50,000 p.a.
  - Reduce the amount spent on Temporary and Agency staff and consultants, across the Council by £1,000,000 p.a.
  - Propose that the Leader remove a Cabinet post, within the Community and Governance Service area, saving £15,000 p.a.
  - Assume additional ongoing savings in 2012/13 onwards, from the various South East 7 action plans, of £280,000 p.a.
  - Property based savings of £500,000 p.a.
- 56.3 The following amendment was moved by Councillor Birch and seconded was LOST:

Replace paragraph 1.7 (3) of the Cabinet's report with the following:

(3) approve, subject to (3) (i) to (3) (iv) below, the revenue budget estimates, for 2012/13 as set out in Annex 3 (a) of the commentary on the Revenue Budget circulated to all members (Appendix 2):

- (i) provide a sum of £1.5m to help mitigate and smooth high impact effects over the next 3 years, arising from the planned changes in the Adult Social Care service offer
- (ii) provide a sum of £0.5m over the next 2 years as an investment in street lighting refurbishment to help compensate for the Cabinet announced proposed annual reduction in street lighting maintenance
- (iii) to provide the sum of £0.5m to use over the next three years, to help mitigate and smooth any high impact reduction in the Children's Services care offer
- (iv) to finance the above with an additional £2.5m reduction in the <u>total</u> of earmarked reserves.
- 56.4 The following motion moved by Councillor Glazier, to adopt paragraph 1 of the Cabinet report was CARRIED:
  - (1) approve the Capital Programme in relation to schemes in progress or about to start and those to start in 2012/13 and 2013/14 and to note the schemes provisionally included in the capital Programme in future years as set out in Annex 5 of Appendix 1;
  - (2) note the prudential indicators as set out in Annex 4 of Appendix 1;
  - (3) approve the revenue budget estimates for 2012/13 as set out in Annex 3 (a) of the commentary on the Revenue Budget circulated to all members (Appendix 2);
  - (4) in accordance with the Localism Act 2011 to agree that:
  - (i) the net budget requirement is £356.351m and the amount calculated by East Sussex County Council as its council tax requirement for the year 2012/13 is £240.824m;
  - (ii) the amount calculated by East Sussex County Council as the basic amount of its council tax (ie for a band D property) for the year 2012/13 is £1158.30 and represents a 0% increase on the previous year
  - (5) the borough and district councils be advised of the relevant amounts payable and council tax in other bands in line with the Regulations and to issue precepts accordingly in accordance with the Agreed schedule of instalments (Appendix 2 Annex 3B)

- e) criteria for selection;

- g) impact of South Downs National Park Local Access Forum;
- h) any other relevant information.

# **Answer by Councillor Maynard**

a) The minimum term of appointment to the Forum is 1 year. Members can join for up to three years with a potential renewal of membership past that point and pending Forum approval.

- c) The Forum is currently looking to recruit off-road cycling and land interest representatives.
- d) Vacancies on the Forum are advertised either with press release (in local press/ESCC publications) or by approaching relevant interest organisations directly.
- e) The selection of successful applicants is based on them meeting the following criteria:
  - 1. Their commitment to working within the terms of reference and achieving the aims of the Forum through constructive working with other members.
  - 2. An ability to attend quarterly daytime meetings and other working-group meetings where necessary.
  - 3. Members must have sufficient experience of the countryside in East Sussex to be able to make an informed and constructive contribution to improving access provision.
- f) The selection of a successful candidate is initially made by application form. If there are several applicants to choose from, then the final decision is usually made by the Chair and Vice-Chair of the Forum. This approach has worked well to date. (Interviews have not yet been necessary as applicants are usually relatively few in number.)
- g) The ESLAF and SDLAF have recently signed a Memorandum of Understanding which defines how the two Forums will work together to manage their respective areas of interest. Since the National Park came into being, the SDLAF is now the statutory Forum for the National Park area in East Sussex. They will therefore take a lead on providing the relevant authorities on countryside access in their area.

The ESLAF's strict remit is to advise on access in the area of East Sussex outside of the SDNP. However, the ESLAF (and SDLAF) can also comment on access across wider areas – this enables effective cross-border working. The ESLAF and SDLAF have also nominated cross-Forum representatives who attend meetings of the other Forum.
