WRITTEN QUESTION PURSUANT TO STANDING ORDER 44

1. <u>Question by Councillor Tutt to Councillor Elkin, Lead Member for Children's and Adults' Services</u>

Would the Lead Member for Children's Services please provide a detailed list of all temporary/mobile classroom facilities in East Sussex schools together with the dates that such 'temporary' facilities were installed?

Answer by Councillor Elkin

Please see the attached table, which details a full list of temporary/mobile accommodation at ESCC maintained schools (ie excluding Academies and Foundation Trust schools), together with the dates of installation of each mobile/temporary facility. This list provides a snap-shot of the current position in many respects, as provision has been made in the 2012/13 capital programme to replace or refurbish a number of the temporary classrooms. Feasibility studies are currently in progress to determine the detail of the investment required. In addition, for several of the Primary schools other permanent solutions are also being progressed.

Additional/Supplementary Information

- It should be noted that across ESCC maintained Primary schools there are some 1,248 <u>classrooms</u>, of which 70 are temporary/mobile accommodation, which equates to only 5.6% of the total number.
- NB Table shows 106 total spaces, however 36 are not classrooms (staff rooms, libraries, group rooms, nurseries etc) and have been excluded from the calculations above
- In relation to ESCC maintained Secondary schools, there are some 1,306 teaching spaces (including specialist spaces such as science labs, music rooms, Design Technology rooms and halls). Of these 51 are in temporary/mobile accommodation. This equates to only 3.9% of the total number.
- NB Table shows 54 total spaces as 3 are not teaching spaces (2 offices, 1 site manager)

Quality of Temporary Accommodation

- Temporary/mobile accommodation installed as part of the CSD Temporary Accommodation Programme from 2010 onwards is required to incorporate significant improvements to energy performance as part of the "total refurbishment" process to meet Building Regulations 2010 standards. As part of the asset management plan, a significant proportion of existing stock is used with substantial refurbishment; typically including increased insulation, new double glazed windows, low energy lighting, water saving features and BRE Green Guide rated materials. Further sustainability measures may also be selected on a project specific basis, such as air source heat pumps, additional tree planting and

landscaping and rain water collection butts. The standard of accommodation now being provided is therefore good.

General Background/Guidance on Use of Temporary Accommodation for Temporary Increases in Pupil Numbers

- The use of temporary accommodation has also been a conscious strand of our capital planning strategy; firstly in order to reconcile statutory requirements and policy to available resources, this is the most cost effective approach in the short and medium term. And secondly, as the forecasts indicate that in some areas pupil number increases will not persist into the long-term, it would be a false economy to invest in permanent solutions at this time.
- At times of pupil growth, the Council uses a two-staged approach to meet its statutory duty to ensure the sufficient supply of school places across the County. For short term 'bulges' in pupil numbers the Council will use temporary accommodation to ensure it can react quickly to provide additional places in areas of pressure. Using temporary accommodation is a recognised way of providing additional places in the short term and it provides a valuable and flexible resource to enable the Council to fulfil its obligations. If the 'bulge' becomes a longer term trend, the Council will consider providing additional permanent accommodation, subject to its compliance with statutory guidance and funding being available through the County Council's Capital Programme. Whilst the Council's wish would be for every child to be educated in permanent buildings, it is important to establish that there is a long term demand for additional places before extra permanent accommodation is provided. This is to reduce the risk of additional permanent capacity exacerbating viability issues in times of low pupil numbers.
- It is generally accepted that not all unfilled places in a school are surplus places, but that some margin of capacity is necessary to allow parental choice, given that there will be volatility in preferences from one year to the next, and to allow for differences in the size of individual cohorts. National guidance (historically provided by the Audit Commission) suggests that between 5 and 10% surplus should be maintained in an area to facilitate parental preference and allow for a margin of error in the pupil forecasts.
