1 Election of Chairman

Councillor Lock (Vice Chairman of the County Council) in the Chair.

1.1 The following motion was moved by Councillor Jones and SECONDED

'To elect Councillor Dowling to serve as Chairman of the County Council for the ensuing year'.

- 1.2 In moving his motion, Councillor Jones paid tribute to the excellent work that Councillor Dowling had undertaken during the past year as Chairman of the County Council.
- 1.3 There being no other nominations, the Vice Chairman put the motion to the vote and declared Councillor Dowling elected as Chairman of the County Council for the ensuing year. Councillor Dowling made a declaration of acceptance of office and took the Chair.

1.4 The Chairman thanked the Council for electing him as Chairman and set out his priorities for the coming year.

WRITTEN QUESTION PURSUANT TO STANDING ORDER 44

1. <u>Question by Councillor Rogers to Councillor Glazier, Lead Member</u> for Community and Resources

Given that

- (i) smoking remains the single biggest preventable cause of ill-health and premature death:
- (ii) that therefore it continues to be the number one public health challenge;
- (iii) that public health responsibilities are moving to local authorities including East Sussex County Council; and
- (iv) that helping our residents and visitors not to embark on an addiction pathway may well be the best method of prevention,

what response has the County Council made to the current Department of Health consultation process on standardised packaging of tobacco products?

If no response has been made to date, please indicate whether it is intended to do so before the closing date of 12 July 2012, and if so, an outline of what that response will contain.

Answer by Councillor Glazier

The County Council has not yet made a response to the consultation which was issued the day this question was submitted. Like the Government, the County Council has not formulated a view on this matter, so it would have been wrong for a response to have been submitted.

I will ask relevant officers to prepare a draft response on those areas of the consultation where the County Council can add to the debate and bring a suggested response to a lead member meeting, in time to meet the deadline for submissions in July.
