Appendix 1: Department of Adult Social Care Action Plan in response to the Adult Social Care and Community Safety Scrutiny Review of Dementia

1	To endorse the implementation of the recommendations from the Adult Social Care report: Framework homecare providers and the care of people with dementia – a report on the current position with regard to specialist training, which envisage a stepped approach to upskilling homecare providers in relation to dementia: • by actively promoting training to independent sector providers (initially managers); • by co-producing action plans with providers to embed the nationally recognised 'Common core principles for supporting people with dementia'; and • by proposing changes to future contract specifications that will require providers to have achieved specific targets.	The report recommending improvements to the training available to Independent sector Home Care Providers (particularly those on the East Sussex Adult Social Care Framework) is being implemented. Training for Independent Sector Home Care Managers and owners has been provided and well attended. Feedback from providers that attended has been positive. This training has initiated additional planning for further staff training. The emphasis on the Common Core Principles provides an effective standard for quality and consistency of the training. The ASC training for dementia that is provided for Independent Providers is being enhanced and promoted more actively in order to increase the take up of existing training packages by Home Care staff. This matches work that is underway within residential care homes to raise the quality of dementia training and support. The Home Care Framework is not due to be re-tendered until 2014, however the lead in time for this work will commence in 2012. Discussions with Home Care Providers through the Home Care Provider Forum have commenced and will continue through the re-tender process. Any changes to the requirement for training staff will be included in the new specification and contract.
