## HOME TO SCHOOL TRANSPORT

33.1 The Chairman reported that Countryliner Bus Services went into administration last week which could have impacted on approximately 1000 children in relation to home to school routes. ### WRITTEN QUESTIONS PURSUANT TO STANDING ORDER 44

# 1. <u>Question by Councillor Rogers to Councillor Elkin, Lead Member for Adults and Children's Services</u>

Of the 138 Church of England clergy in the Diocese of Chichester said by the Archbishop's recent report to be lacking CRB checks,

- a) how many serve on governing bodies of schools within East Sussex? and
- b) how many otherwise have access to children within East Sussex schools, for example by conducting assemblies?

What advice has been given to heads and chairs of governors about this issue?

## **Answer by Councillor Elkin**

In general terms Councillor Rogers will know that these matters are the responsibility of the Diocese of Chichester, and not the County Council. However, the Director of Children's Services, and the Chair of the East Sussex Safeguarding Children's Board, have been in correspondence with the Diocese and Lambeth Palace about their concerns about safeguarding practice in the Diocese, and these concerns are in the public domain.

The answers provided by the Diocese to his specific questions are:

- "a) The Diocese of Chichester advises that there are now no clergy in the diocese who have not had a CRB check. Every church school has a place available for the local clergy to take up, however this does not happen with every school. It is a matter for individual schools and clergy to determine between them. The Diocese do not currently keep records of which clergy are on Governing Bodies. [When the local authority is notified of any new governor at a school, a List 99 Check is carried out. While it is not a statutory requirement, many schools additionally choose to also carry out their own CRB Checks of Governors.]
- b) The Diocese, does not have records of ad hoc visits by Governors to schools of the nature described. The vetting and barring scheme (VBS) was created by Government to help safeguard children and adults by introducing new measures, including monitoring and registration requirements for individuals going into schools. However the frequency, intensity and timings of visits required before registration and checks are necessary mean that it is very unlikely that any governor or individual conducting the occasional assembly would be subject to its provisions. "

The Diocese does not provide safeguarding advice to its clergy who become Governors. [The Local Authority provides a full induction and training programme for all Governors which includes face to face and online courses on their role in safeguarding children.]

In addition, the Director of Children's Services is discussing with the diocesan authorities how he can support them in improvements to their safeguarding practice identified as necessary in the recent Visitation report."
