65. Chairman's Business

OFSTED INSPECTION

All members joined the Chairman in congratulating staff within Children's Services and partner agencies on a very good outcome from the Ofsted inspection that was published last week. Ofsted has judged the Council 'good' at safeguarding children at risk and at supporting and planning for children in care. The Local Safeguarding Children Board was also judged to be good. It is the first inspection for the Council under Ofsted's tougher new inspection rules that came into force last November, using a single inspection framework to bring together judgment on child protection (including early help), services for looked after children and care leavers, as well as adoption services. The overall 'good' grading highlighted the need for the Council to continue to improve the experiences and progress of some young people leaving care but also featured the rare accolade of an 'outstanding' judgement for Adoption and permanence planning for children. Of those reports published East Sussex has received the only 'outstanding' to date. The THRIVE transformation programme received particular recognition in the report, with inspectors citing how it is 'clearly having a positive impact on improving outcomes for children and families.' Lead members were praised for the way in which they work with senior managers and act as 'champions' for Children's Services. Members were also recognised for their acute awareness of the challenges faced by looked after children and care leavers and how they work well with 'senior managers and social workers to ensure all East Sussex children and families receive the right level of support to help them, including those who live out of the county in placements some distance from home.'

The inspectors highlighted areas where improvement could and should be made and Children's Services will continue to work to make further progress. Overall this is a fantastic result though and a real boost to the morale of staff who work so hard day in and day out to do their very best for the children of East Sussex. Councillors Glazier and St Pierre also spoke and congratulated all involved.

65.2 On behalf of the Council the Chairman thanked Ged Rowney for his work as interim Director of Children's Services and in particular for his contribution to working with the Ofsted Inspection Team. The Chairman stated that the authority was looking forward to welcoming the new Director, Stuart Gallimore, at the end of April

LEXEL INSPECTION

WRITTEN QUESTION PURSUANT TO STANDING ORDER 44

1. Question by Councillor Lambert to the Lead Member for Transport and Environment

At its meeting on 28 January 2014, Cabinet considered a report on the Newhaven Household Waste Recycling Site – Capacity and Operating level. The report stated that the Newhaven HWRS is a large site with a permitted capacity for 75,000 tonnes of waste annually. The HWRS Service Review 2013 Evidence Base states that in line with the development and use of the Energy Recovery Facility in Newhaven, residual waste to landfill has decreased and waste sent for energy recovery has increased. Approximately 60,000 tonnes of waste was dealt with across all HWRS in 2011/12. The annual waste tonnage at Newhaven was 6,489 tonnes.

The HWRS built in Newhaven for some £2 million therefore appears to have been massively over-specified as it was already capable when opened in July 2011 of handling the entire County's waste although the operating level is currently a mere 9% of capacity.

Can the Lead Member explain why capital investment was made by the County Council in the Newhaven HWRS to create an apparently un-necessarily large facility?

Answer by the Lead Member for Transport and Environment

The Newhaven Household Waste Recycling Site (HWRS) has an annual 'permitted capacity' of 75,000 tonnes. This is the maximum amount of waste that the site is permitted to accept under its Environment Agency permit. This is not the same thing as the operational capacity of the site, i.e. the amount of waste that the site can physically handle, given the infrastructure on site and the site design and layout. There is no defined operational capacity for the Newhaven HWRS, and the amount of waste it can handle is largely dependent on the overall size of the site, number of containers on site, how the site is laid out within its footprint, how many people use the site, and how often it is serviced for container emptying.

The site at Newhaven has not been massively over specified, however the site does have some space to accommodate additional waste and recycling containers if needed. As part of the consultation on HWRS closures, we estimated that the Newhaven HWRS could comfortably handle waste from Seaford and Newhaven, equivalent to around 12,000 tonnes per year. The figure of 75,000 tonnes permitted capacity was included only to show that there would be no restrictions from the Environment Agency in regard to handling waste from Seaford and Newhaven at the site.
