QUESTION FROM MEMBERS OF THE PUBLIC

1. Question from Colin Frost-Herbert, Lewes, East Sussex

In the mid 1960s a bus fare for about a half mile ride through my Sussex town cost about the same as a box of matches or a Daily Mirror, about 2d (old currency). Today those items cost 30p and the bus fare is £2.40. This is 8 times more than the 1960s equivalent. Does the Lead Member believe that this is a contributory reason that buses do not attract all the passengers they might?

Response by Councillor Maynard, Lead Member for Transport and Environment

9.7 billion passenger journeys were made by bus in Great Britain in 1968, according to the Office of National Statistics.

Last year there were 5.2 billion passenger journeys.

Fare levels are a matter for the commercial bus operators. Fares have to be set at a level necessary to cover the cost of provision. Reducing fares, we understand, rarely attracts sufficient additional passengers to cover the fares income lost.

The biggest reason why bus use has declined is undoubtedly the increase in car ownership level compared to 1960 levels. Inflation in fuel prices since the 1960s also contributes to the increase in costs.
