BEXHILL KING OFFA BY-ELECTION

22.1 The Chairman welcomed Councillor Ensor and congratulated him on his recent election to the Council.

22.2 The Chairman announced that the Lord Lieutenant would be retiring at the end of July. Phyllida Stewart-Roberts OBE had been appointed Lord Lieutenant of East Sussex in 2000 and had been a wonderful ambassador for East Sussex. On behalf of the County Council the Chairman wished her a long and happy retirement.

'This Council notes the reported remarks of LGA Chairman Sir Simon Milton that local authorities should not be involved in the provision of education and that private business should be encouraged to run state schools at a profit. It is understood that any comments were made in a personal capacity; they do not reflect the policy of the LGA. Regardless of what Sir Simon Milton (the out-going Chairman of the LGA) may or may not have said, East Sussex County Council will continue to be responsible for and involved in providing the best possible education opportunities available for the young people of East Sussex as appropriate to individual needs.'
