12. PETITION REGARDING EAST CHILTINGTON SCHOOL BUS ROUTE

- 12.1 The Lead Members considered a report by the Director of Children's Services which concerned the petition presented by Councillor St Pierre to the Chairman at the County Council meeting in July.
- 12.2 Mrs Michelle Pearce and Councillor Sarah Osborne (Lewes District Council) as lead petitioners addressed the Lead Members.

DECISION

- 12.3 RESOLVED (1) to seek clarification from the County Council's Economy, Transport and Environment Department as to points raised by the petitioners regarding the assessment of the route; and
- (2) instigate a further assessment should the clarification process reveal a need for such an assessment.

Reason

12.4 A full understanding of the route and patterns of user is required.

13. SURPLUS AND UNUSED LAND HOLDINGS AT SCHOOLS

13.1 The Lead Members considered a report by the Director of Children's Services which sought Lead Member support for the investigation of potential land use at schools which might convert to Academy or Foundation Trust status.

DECISION

- 13.2 RESOLVED (1) to agree, in respect of the land as shown hatched on the plans and described on the schedule attached to the report, that further investigations be undertaken to establish the potential for development of surplus and unused land at schools, and consideration in partnership with the affected schools (where appropriate) to retaining or disposing of that land; and
- (2) that the County Council seeks to secure the retention of land and buildings which provide a range of different services, including for example Children's Centres, which do not fall directly in an individual school's remit; and
- (3) to delegate the Director of Children's Service to take appropriate action, including but not limited to the appropriation of land to a different statutory purpose to achieve resolutions (1) and (2) above; and
- (4) that local members should be kept informed of progress with the investigations.

Reason

13.3 In order to ensure the County Council's estate is managed appropriately further information and advice is required.
