- 11. PROPOSED EXPANSION OF ST ANDREW'S CE INFANT SCHOOL AND TOLLGATE COMMUNITY JUNIOR SCHOOL: FEEDBACK FROM CONSULTATION
- 11.1 The Lead Members considered a report by the Interim Director of Children's Services which sought approval to publish statutory notices in respect of a proposal to expand St Andrew's CE Infant School and Tollgate Community Junior School by September 2016.

DECISION

- 11.2 RESOLVED to (1) approve the publication of statutory notices in respect of a proposal to expand St Andrew's CE Infant School and Tollgate Community Junior School by 90 places and 120 places respectively from September 2016; and
- (2) delegate authority to the Interim Director of Children's Services to amend the proposals prior to publication if required.

13. PROPOSED EXPANSION OF ROBSACK WOOD COMMUNITY PRIMARY SCHOOL: FEEDBACK FROM CONSULTATION
