Title of Report Post 16 Transport, 2014/15

Purpose of Report To approve the Post 16 Transport Policy for 2014/15

### **RECOMMENDATIONS:**

#### The Lead Member is recommended:

1) to note the changes to the Post 16 Transport Policy;

2) to agree the post 16 transport statement for 2014/15 for learners aged 16 - 18 in further education, continuing learners aged 19 and over and young people aged 19 - 24 with learning difficulties: and

3)note the continuing support for Further Education students from low income families, and the continuation of subsidised rail fares open to all students regardless of family income as shown in Appendix 1.

### 1. Financial Appraisal

1.1 Transport for post-16 students is funded from two sources; the Home to School Transport Budget (HTSTB) and the Post-16 Transport Budget which funds the student transport grants. The cost of providing post-16 transport in the 2013/14 financial year was just over £631k from the HTSTB and £223k from the Post-16 Transport Budget.

1.2 In order to make the required Medium Term Financial Plan (MTFP) savings from HTSTB (as agreed by County Council), a number of discretionary payments for statutory aged pupils were reviewed. Following a consultation process it was agreed that students with SEND would be means tested and those that were not on low incomes, would pay an annual contribution of £370 towards their travel costs, with a 25% discount for second or subsequent students from the same family. This amount was the average charge of all the authorities with this policy at the time of the recommendation, and it was comparable with the annual contribution charged in West Sussex which is currently £360.

1.3 Mainstream post-16 students are already means-tested for all support for post-16 transport with the exception of subsidised rail travel. For students where there is no public bus service, annual grants are paid in three instalments. There are three levels of annual grant depending on the distance the student has to travel. Following a consultation process proposals were agreed by Lead Member to make minor reductions in the grants being paid and details are given in the draft Transport Statement attached as Appendix 1.

### 2. Background/Supporting Information

2.1 As a result of MTFP savings requirements the County Council consulted on a number of proposals to change transport policies and the changes were subsequently agreed by Lead Member. These include the changes detailed in 1.2 and 1.3 above. The Post 16 transport policy now needs to reflect the agreed changes.

2.2 Current post-16 transport guidance requires local authorities to consult annually on the support they are proposing to provide for post-16 learners. A statement of the provision to be made should then be published on the local authority's website, and this should be done by 31 May each year. We will be publishing slightly later than the guidance suggests due to unavoidable delays due to ongoing discussions with Southern Rail.

2.3 The draft post-16 transport statement was consulted on from 23 May 2014 until 27 June. Any comments received will be tabled at the Lead Member meeting. It was sent to FE providers in East Sussex and all secondary schools in East Sussex. Existing post-16 students and those currently in Year 11 have been asked for their comments through providers.

## 3. Conclusion and Reason for Recommendation

3.1 Although there is an expectation that young people will remain in some form of education or training until they reach the age of eighteen, the statutory school age has not changed and remains at 16. Support with post-16 transport is therefore discretionary. Despite this and considering the difficult financial challenges faced by the County Council, support for students with the greatest financial need will continue for 2014/15. However, Lead Member is advised that provision will need to be reviewed again for 2015/16.

3.2 The full details of the support to be provided are attached in the draft Transport Statement which is attached as Appendix 1.

3.3 Lead Member is recommended to note the continuing support for FE students from low income families, and the continuation of subsidised rail fares open to all students regardless of family income. Lead Member is also asked to note the amendments that have been made to the policy to reflect the change agreed by Lead Member to reduce the annual travel grants in line with the required savings outlined in the MTFP and the introduction of means-testing post-16 students with learning difficulties or disabilities.
