3 David Skinner – Head of RS at Seaford Head School

- 3.1 Mr David Skinner (DS) gave an overview of the work within RS at Seaford Head School. The following points were noted:
 - The subject has a strong standing in the school and is called the Department of Ethics
 - It is a discreet subject in Key Stage 3
 - Years 7 and 8 focus on 5 major world religions including Christianity, Judaism, Islam, Hinduism, Buddhism
 - Year 9 start the GCSE course
 - · Life issues and morality units are included
 - Key stage 4 is largely ethics based and focus on Christianity and Hinduism
 - Last year 99 students completed the GCSE course and 83% of the students achieved grades A* to C

DS raised the concern that in the academic year 2013/14 there is a challenge being faced in RE; the school will be expected to deliver RE within one year (Year 9). It is understood that this will be reviewed after one year.

Rosemary Roberts (RR) stated that the majority of students at Year 9 do not have the maturity for GCSE until Year 11 and will not achieve in the same way.

DS agreed with this comment, students do not develop and mature at this stage.

Peter Ward (PW) thanked DS for presenting to the group. PW suggested looking at the NATRE survey which collects information regarding short and long course GCSE's.

4 RE View

Lilian Weatherley (LW) gave an overview of the RE View (copy on Czone) The following points were noted:

Andrew Jervis (AJ) commented that the cost to apply of £475.00 is very high, especially for a small Primary school budget. LW agreed to raise this with the LW organisers.
