Site 8 - All Saints Street

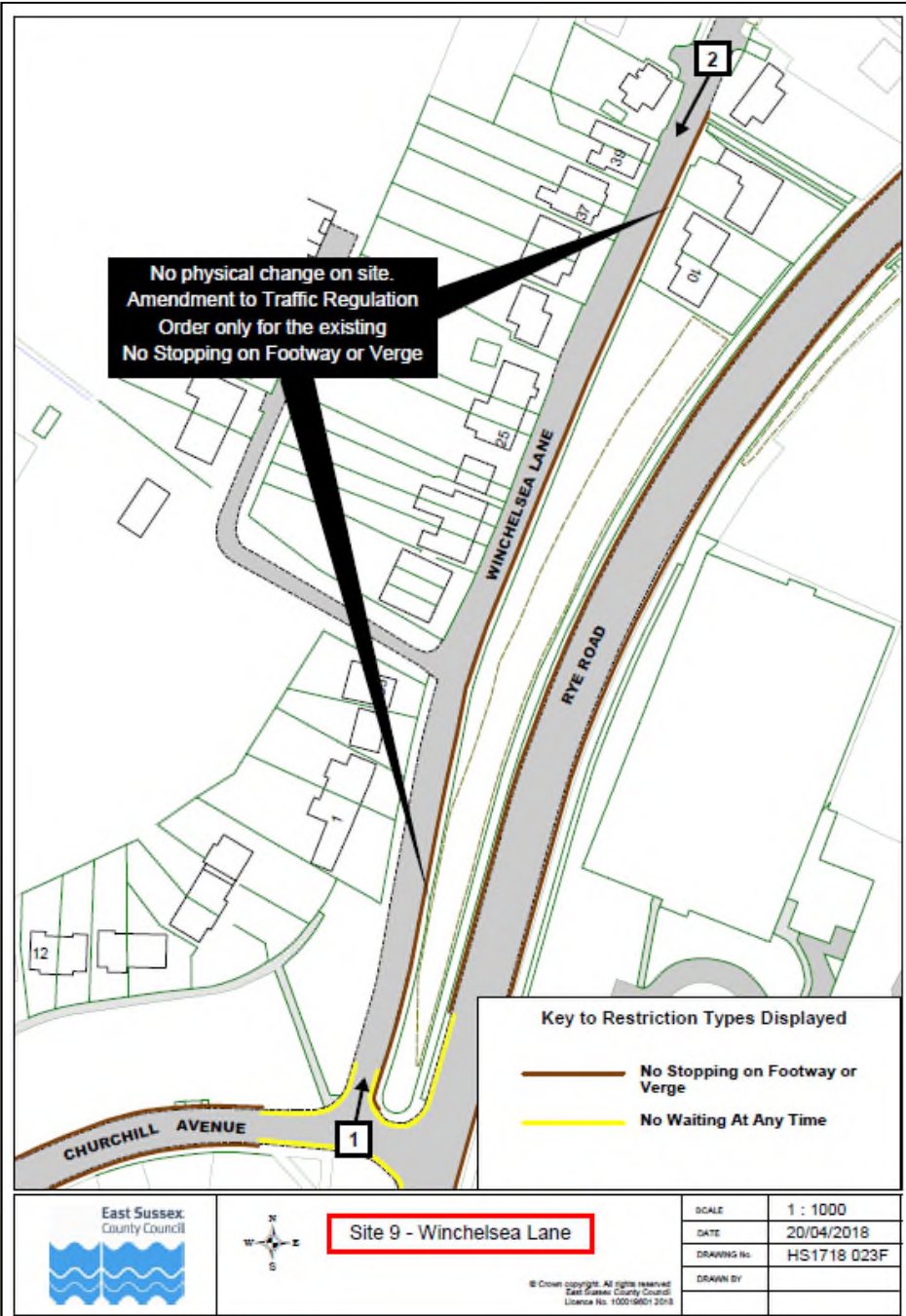

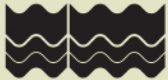


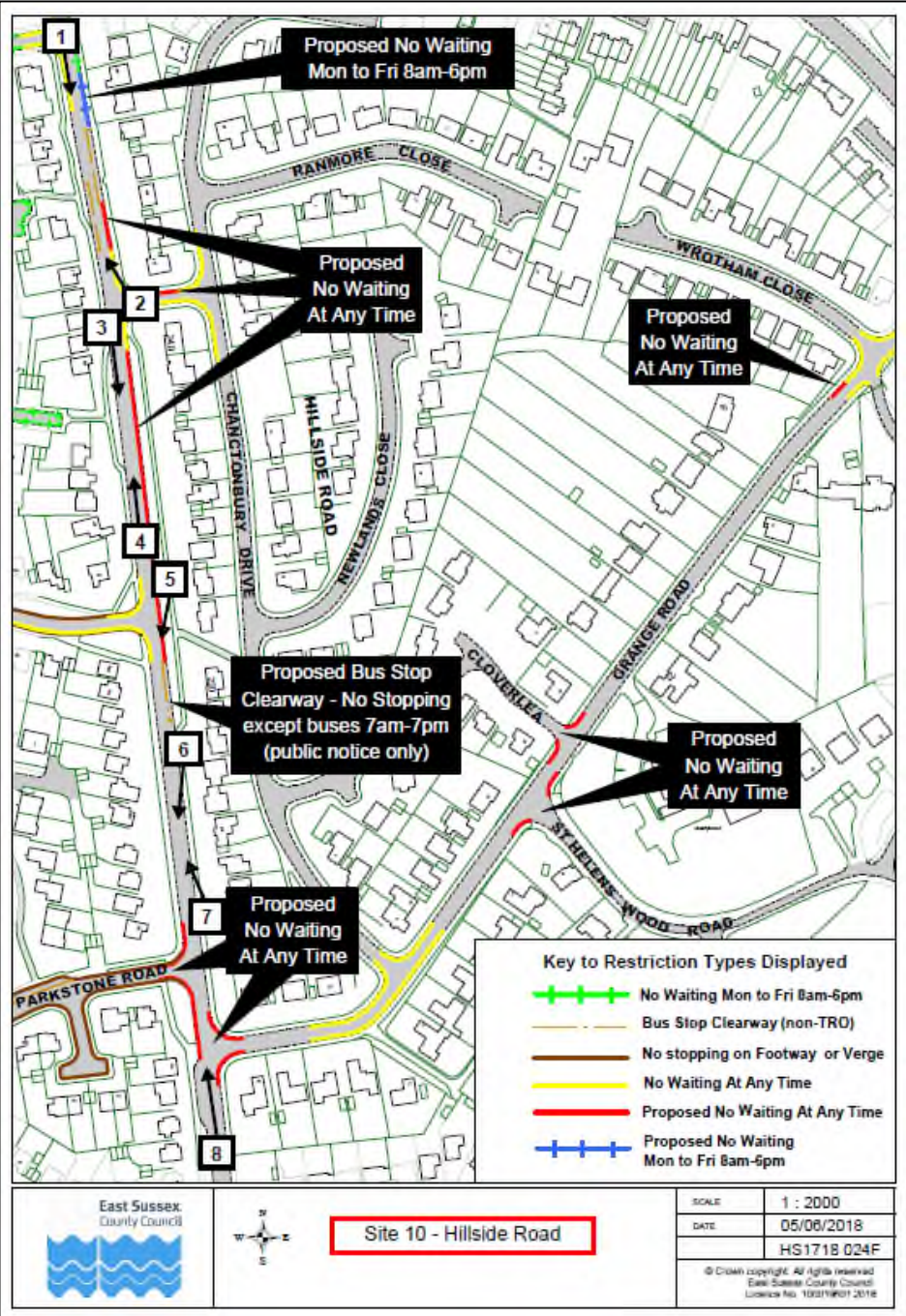


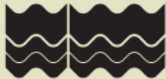


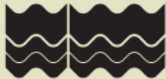


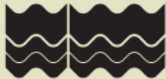




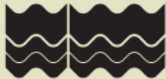


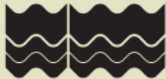




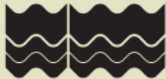


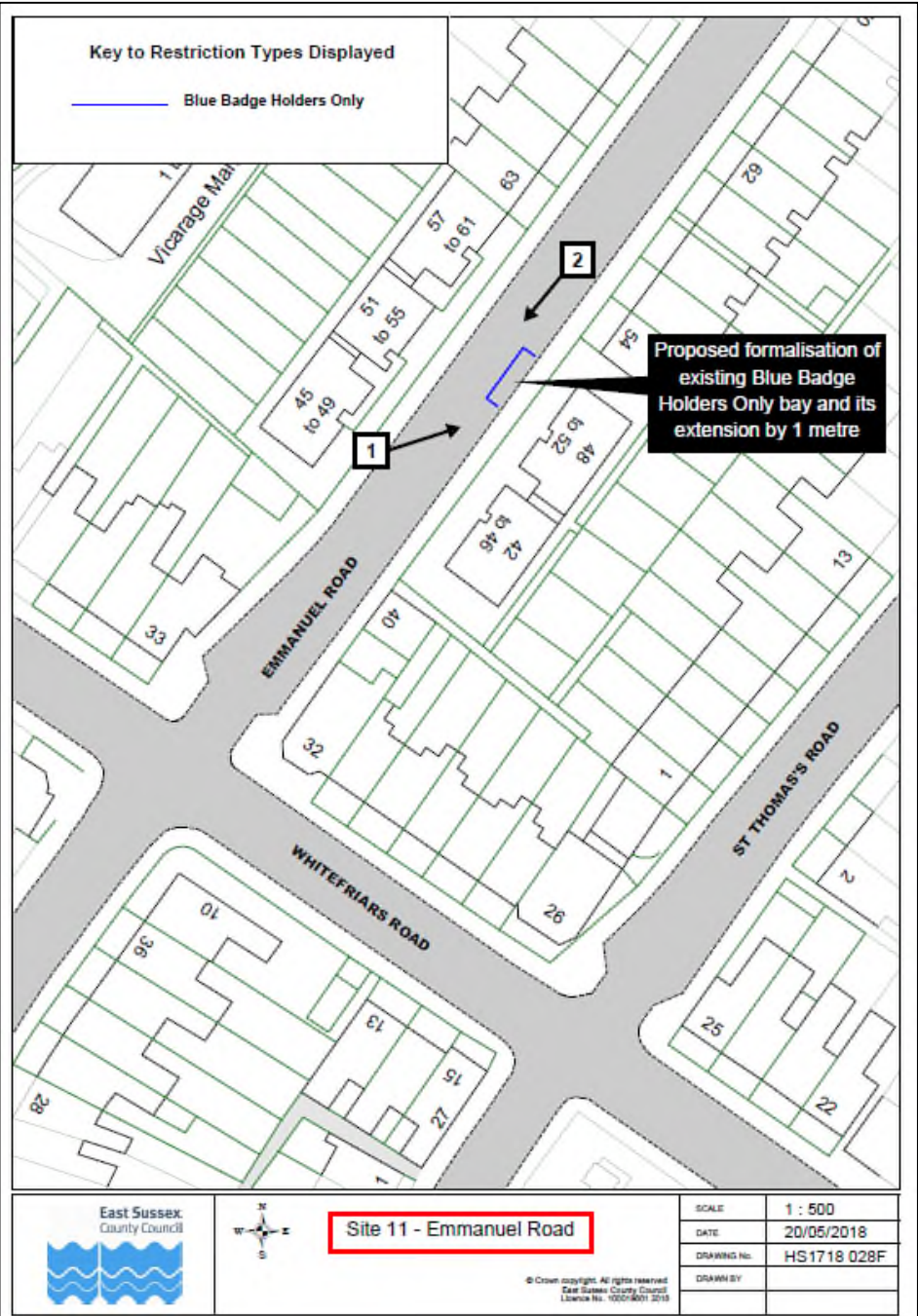






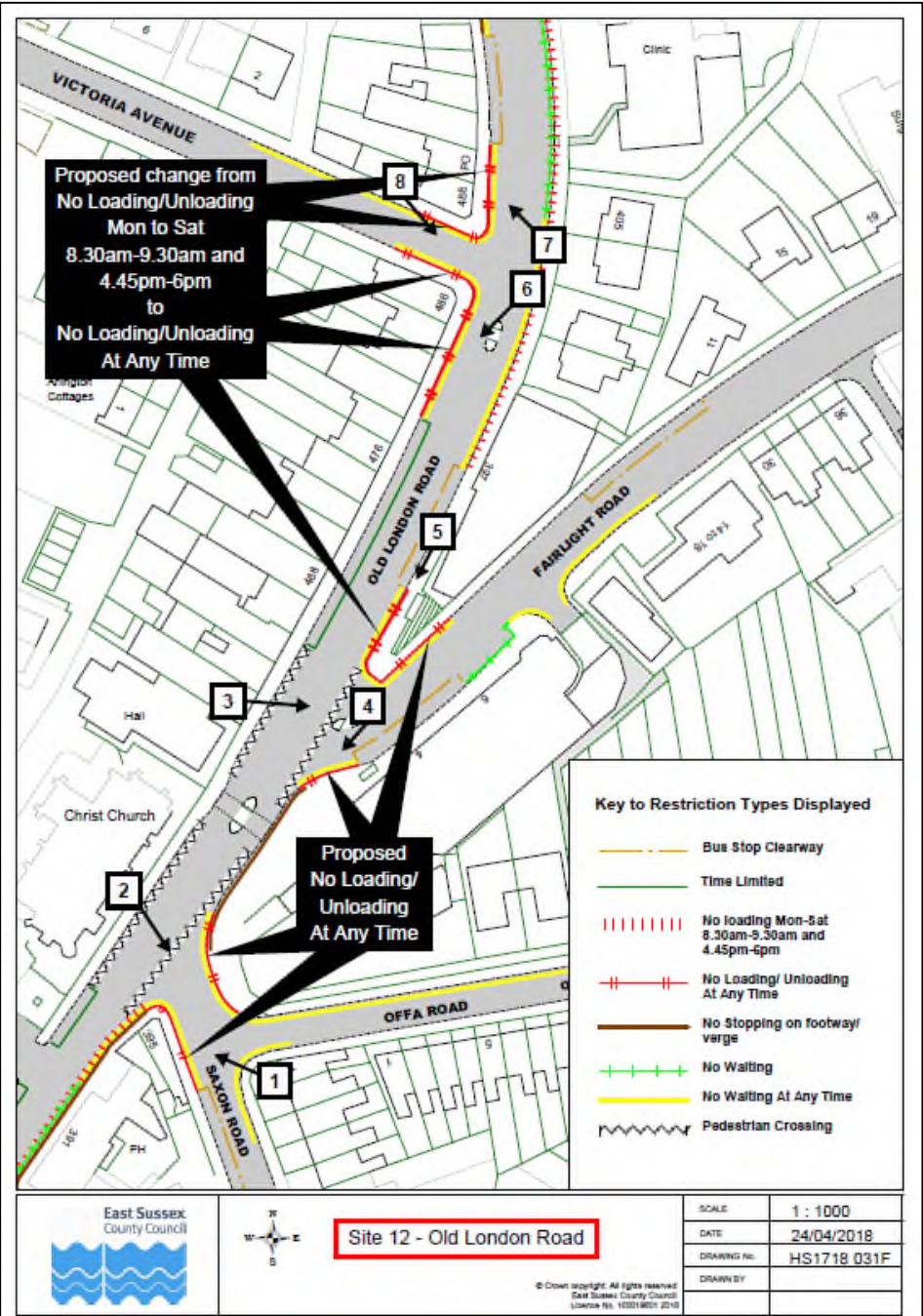




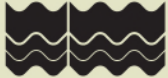






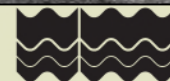






View 3 – Looking eastwards across Old London Road towards its junction with Fairlight Road

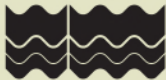

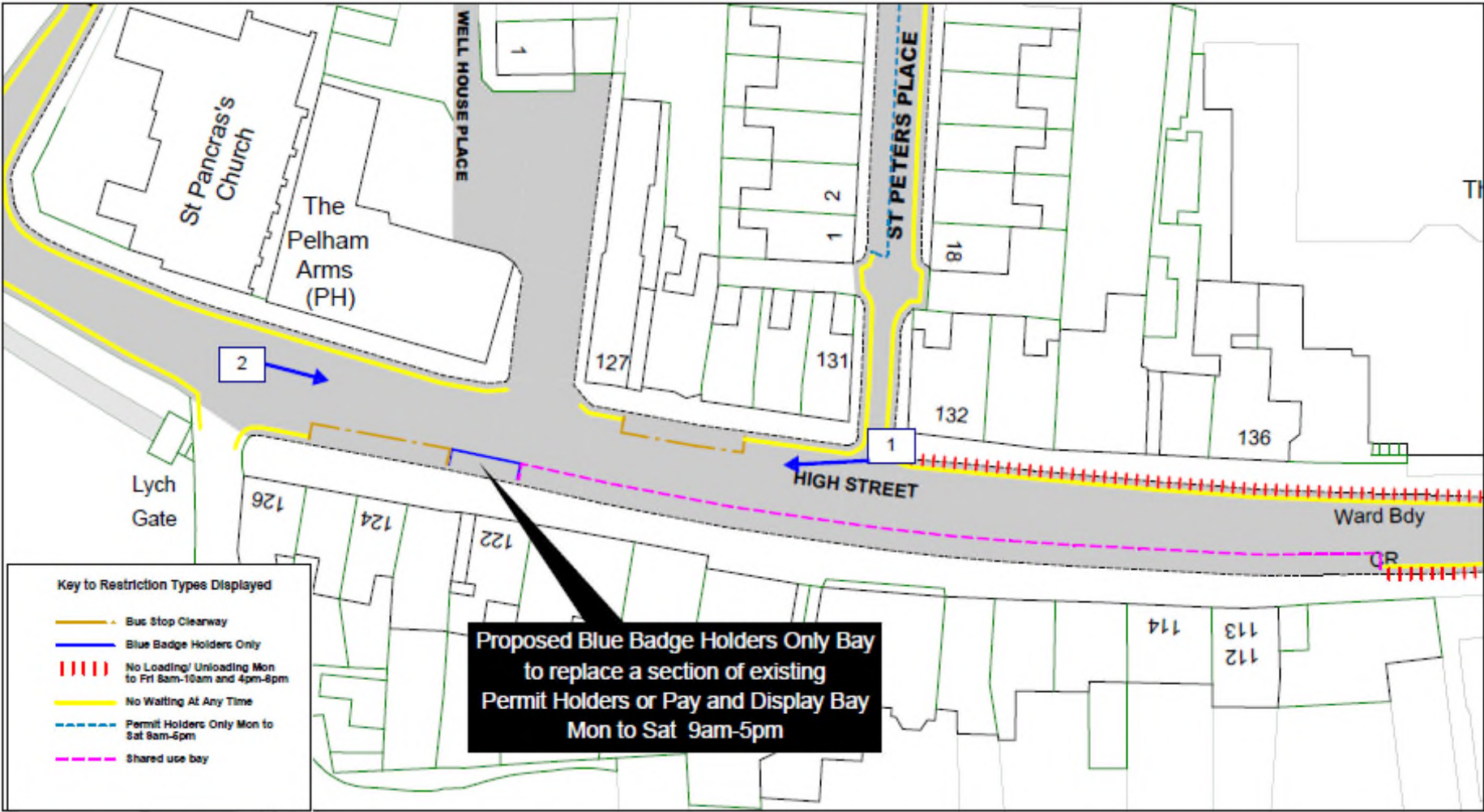






View 5 – Looking north-eastwards along Lansdown Place from its junction with Station Street
