#### 7 PROPOSED EXPANSION OF CRADLE HILL COMMUNITY PRIMARY SCHOOL

- 7.1 The Lead Member considered a report by the Director of Children's Service regarding the proposed expansion of Cradle Hill Community Primary School.
- 7.2 Mr and Mrs Newbold, the lead petitioners, spoke in support of the petition.
- 7.3 It was RESOLVED to approve the expansion of Cradle Hill Community Primary School from 420 places to 630 places effective from 1 September 2017, conditional upon planning permission for the enlargement of the premises being granted under Part 3 of the Town and Country Planning Regulations 1992 by 31 December 2016.

#### Reason

7.4 In responding to a growing demand for primary school places in Seaford, the Local Authority believes the expansion of Cradle Hill Community Primary School from 420 places to 630 places is essential if it is to fulfil its statutory duty to provide sufficient school places.

Purpose of report: To seek Lead Member approval to lower the age ranges at Grovelands

Community Primary School and Hurst Green CE Primary School to enable the governing body of each school to incorporate the onsite

third party nursery provision.

#### **RECOMMENDATIONS:**

The Lead Member is recommended to:

- 1) authorise the change of age range at Grovelands Community Primary School from 4 to 11 to 2 to 11 with effect from 1 September 2016; and
- 2) authorise the change of age range at Hurst Green CE Primary School from 4 to 11 to 2 to 11 with effect from 1 September 2016.

#### 1 Background

- 1.1 Both schools currently have third party nursery providers on site who lease space from the school to operate provision for 2 to 4 year olds. The governing body of each school wishes to take on the management of their respective nursery provision by lowering their age range from 4 to 11 to 2 to 11.
- 1.2 The aim of each proposal is to integrate, fully, nursery provision into the Early Years Foundation Stage within each school. The governing bodies wish to ensure that their respective nurseries continue to support their local area and to offer high quality early education delivered by experienced and well-trained staff across the Early Years Foundation Stage. The aim is to build on the work already done by the schools and nursery providers to secure good outcomes for all children in the future.

#### 2 Supporting information

#### **Grovelands Community Primary School**

- 2.1 The governing body consulted between 22 June and 20 July 2015 on the proposal to lower their age range. The governing body consulted with staff, families of children at the school, the local community and other interested parties. Two responses were received, the details of which can be found in **Appendix 1** (first bullet point, section 3).
- 2.2 On 16 May 2016, the Lead Member approved the publication of statutory notices in relation to the proposal. The statutory notice was published on 27 May 2016 in the Sussex Express. The notice was also posted on the entrance to the school. The notice and full proposal was also posted on the Local Authority's website.
- 2.3 Publication of the notice was followed by a four-week period of representation, when comments or objections could be made to the Local Authority. At the end of the representation period, no comments or objections had been received.

#### Hurst Green CE Primary School

- 2.4 The governing body consulted between 15 March and 22 April 2016 on the proposal to lower their age range. The governing body consulted with parents and carers of children at the school, staff, the local community and other interested parties. Two responses were received, the details of which can be found in **Appendix 1** (second bullet point in section 3).
- 2.5 On 16 May 2016, the Lead Member approved the publication of statutory notices in relation to the proposal. The statutory notice was published on 27 May 2016 in the Kent and Sussex Courier. The notice was also posted on the entrance to the school. The notice and full proposal was also posted on the Local Authority's website.
- 2.3 Publication of the notice was followed by a four-week period of representation, when comments or objections could be made to the Local Authority. At the end of the representation period, no comments or objections had been received.

#### 3. Factors to be considered by the decision maker and types of decision

- 3.1 Proposed changes to the organisation of maintained schools have to follow a prescribed process established by the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 ('the Regulations). Schedule 3 of the Regulations requires the proposed changes to be published on a website and must set out:
  - 1) how copies of the proposals may be obtained;
  - 2) that any person may object to or comment on the proposals and the address of the local authority to which any objections or comments should be sent; and
  - 3) the date by which such objections or comments must be sent. That date is within four weeks from the date of publication.
- 3.2 Schedule 3 also requires that a notification of the proposals (including the address of the website where the proposals are published) is published in a local newspaper.
- 3.3 The process set out above complied with these requirements.
- 3.4 The regulations set out a number of factors to which the Lead Member should have regard before making a final decision on the proposed changes. These are set out in **Appendix 1.**

#### 4. Conclusion and reasons for recommendations

- 4.1 In conclusion, we believe the proposal to lower the age ranges at both schools will help to build on work already done by the schools and nursery providers, ensuring a fully integrated Early Years Foundation Stage to help secure good outcomes for all children.
- 4.2 For this reason, the Lead Member is recommended to:
  - authorise the change of age range at Grovelands Community Primary School from 4 to 11 to 2 to 11 with effect from 1 September 2016 and
  - 2) authorise the change of age range at Hurst Green CE Primary School from 4 to 11 to 2 to 11 with effect from 1 September 2016.

1	Did the published notices comply with statutory requirements	The notices complied with statutory requirements as set out in 3.1 of the report.
2	Are the proposals related to other published proposals	The proposals to lower the age ranges at Grovelands Community Primary School and Hurst Green CE Primary School are not related to other published proposals.
3	Was consultation carried out prior to the publication of notices	The Governing Body of each school undertook a period of consultation on a proposal to lower their age range from 4-11 to 2-11 to allow them to take on the management of the on-site third party nursery provision. The findings of each consultation are set out below.  • Grovelands Community Primary School. The consultation period ran
		from 22 June to 20 July 2015. The school consulted with parents, staff, governors, local nurseries, parent and toddler groups, local community. Two responses were received. One respondent was in favour, citing that it would provide a consistent education from the age of two. The other respondent did not express a view either way but did indicate that if the proposal meant more children at the school there would be an impact on traffic in the area. For clarification, the proposal is to incorporate the current nursery provision into the school, not to provide new provision in addition to the existing nursery.
		<ul> <li>Hurst Green CE Primary School. The consultation period ran from the 15 March to 22 April 2016. The school consulted with parents, staff, governors, local nurseries, parent and toddler groups, local community. Two responses were received during the consultation period. One respondent thought the proposal would generally be positive for the children. The other respondent didn't give a view either way but was keen to understand what the change would mean for children, staff and parents.</li> </ul>
4	Have any particular comments or objections been raised during the representation period which could directly affect the proposals	No comments or objections were received during the representation period.
5	The effect on education standards and diversity of provision	The Local Authority does not believe either proposal will have a negative impact on other providers, schools and academies in the surrounding areas as it will simply change the management arrangements of each nursery.
6	The demand for places	The proposal is about changing the management arrangements for the nursery to support its long term sustainability and promote excellence across the Early Years Foundation Stage; it will not provide additional places. Based on current eligibility criteria, forecasts of need in the area indicate there are sufficient early years places to meet demand over the coming years.
7	The impact on school size, premises and funding	The proposals will not affect the size of either school, which will remain at their current capacities. The proposals do not require a change to the premises and assuch will not require funding to implement them.

8	The proposed admission arrangements	The proposals will not affect the admission arrangements of any of the schools, which will remain as published.
9	National curriculum	Both schools will deliver the Early Years Foundation Stage for children aged 2-5 years.

Purpose of report: To seek Lead Member approval to publish statutory notices in respect of a

proposal to enlarge Meridian Community Primary School for the 2018/19

academic year.

#### **RECOMMENDATIONS:**

The Lead Member is recommended to:

- 1) Authorise the publication of statutory notices in respect of a proposal to enlarge Meridian Community Primary School by one form of entry (30 places per year group, 210 places overall) for the 2018/19 academic year; and
- 2) Delegate authority to the Director of Children's Services to amend the proposals prior to their publication if required.

#### 1 Background

- 1.1 There has been an increasing demand for school places in Peacehaven and the surrounding areas. In recent years births in the Peacehaven area have risen from 175 in academic year 2003/04 to 254 in 2013/14. There are also plans to build around 900 new homes in Peacehaven and Telscombe between 2015 and 2030. As a result, a significant ongoing shortfall of school places is forecast in Peacehaven.
- 1.2 In response, the Local Authority undertook a period of public consultation on a proposal to enlarge Meridian Community Primary School for the 2018/19 academic year to create an additional form of entry (30 places per year group, 210 places overall) in Peacehaven. If the proposal is accepted then the school would grow gradually between September 2018 and September 2025 as it fills from reception year upwards. The school would reach capacity when it has 90 children in each year group from Reception to Year 6 a total of 630 children taught in 21 classrooms.

#### 2 Supporting information

- 2.1 Proposed changes to the organisation of schools have to be permitted by the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 ('the Regulations'). These proposals comply with this requirement on the basis that the Regulations permit an enlargement of the premises of the school which would increase the capacity of the school by:
  - 1) more than 30 pupils; and
  - 2) by 25% or 200 pupils (whichever is the lesser).
- 2.2 Public consultation took place over a 5 week period between 6 May and 10 June 2016. Approximately nine hundred and fifty (950) consultation documents were distributed to interested parties including: parents and carers, pupils, staff, local schools, the district and town councils, the local MP and the local community. The consultation was also made available on the Local Authority's website. **Appendix 1** explains the consultation process in more detail and sets out the responses received during the consultation period.
- 2.3 In addition, a public information event was held at the school on Tuesday 14 June primarily to communicate information to school stakeholders around the build element of the expansion prior to the submission of a planning application. The event was advertised via school book bags and flyers distributed to local households and the nursery. The event generated a turn-out of approximately 80 people, largely neighbours of the school. The architects, developers, the transport consultant and ESCC representatives were all available to discuss the plans and listen to comments and feedback.

- 2.4 In summary there was a mixed response to the consultation and the public information event. Those in favour of the proposal recognise the need for additional school places linked to new housing in the town and the benefits it would bring to an ever growing community. Those who raised concerns about the proposal did so generally for the following reasons:
  - Traffic congestion and parking
  - Loss of playing field and facilities
  - Peacehaven Heights should be enlarged instead
  - A new school should be built in the town
- 2.5 In response to these particular points:
  - A number of people who raised parking and traffic congestion as an issue do not fundamentally object to the proposal to enlarge the school. Following feedback from the consultation and the public information event, the design team, including the transport consultant, has agreed to look at a series of highway improvements to ease congestion and irresponsible parking. These proposals are likely to include increased double yellow lines near the school site and the possibility of opening up an existing access point for site maintenance to parents and children. Any measures would require support from East Sussex Highways through the planning system.
  - The school's facilities would be enlarged to accommodate the increased number of pupils. The Local Authority would ensure that the design solution makes best use of the site to create an environment that has a positive impact on teaching and learning.
  - Peacehaven Heights Primary School was considered for expansion but the infant site is very
    restricted and does not have the capacity for enlargement. The cost of moving the whole school to
    the junior site and enlarging it was also considered but the site is smaller than the Meridian
    Community Primary School site and the cost of such a proposal would most likely exceed the
    resources available in the capital programme.
  - A new school was also considered but a search for land in the town which could be developed for
    a new school proved unsuccessful. Even if the Local Authority had found a site that would be
    suitable it is likely that it would have had to purchase it something the Local Authority does not
    have funding for in its capital programme. Another concern the Local Authority had about
    establishing a new one form entry primary school was how viable it might be in the long term in
    terms of its financial sustainability.

#### 3 Conclusion and reasons for recommendations

- 3.1 In conclusion, there was a mixed response to the consultation with a number recognising the need for Meridian Community Primary School to grow. The main concerns raised related to traffic congestion and parking; the Local Authority believes that these concerns can be addressed through the detailed design and planning stage and the design team is already looking at a number of highway improvements that could be made subject to approval through the planning process.
- 3.2 The Local Authority has a legal duty to ensure there is sufficient school provision in Peacehaven to meet the increasing demand for places. It believes Meridian Community Primary School is the right solution to address the need for places and therefore recommends that the Lead Member:
  - 1) Authorises the publication of statutory notices in respect of a proposal to enlarge Meridian Community Primary School by one form of entry (30 places per year group, 210 places overall) for the 2018/19 academic year; and
  - 2) Delegates authority to the Director of Children's Services to amend the proposals prior to their publication if required.
- 3.3 Publication of notices would trigger a further 4 week period of consultation, known as the representation period, when people can again have their say on the proposal. Within two months of the end of the representation period, the Lead Member must make a final decision on the proposal taking into account the views of all those affected by the proposal or who have an interest in it. It is anticipated that a final decision would be taken in September 2016.

#### 1. Introduction

- 1.1 The purpose of this report is to provide the Lead Member for Education and Inclusion, Special Needs and Disability with the outcome from the consultation on the proposal to enlarge Meridian Community Primary School by one form of entry (30 places per year group, 210 places overall) for the 2018/19 academic year.
- 1.2 The proposal is part of the Local Authority's strategy to ensure it is able to discharge its legal obligation to provide sufficient school places in Peacehaven to meet demand both now and in the future.
- 1.3 If the proposal is accepted the the school would grow gradually between September 2018 and September 2025 as it fills from reception year upwards. The school would reach capacity when it has 90 children in each year group from Reception to Year 6 a total of 630 children taught in 21 classrooms.

#### 2. Department for Education (DfE) regulations

2.1 Proposed changes to the organisation of schools have to follow a prescribed process established by the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013. This process complied with these requirements.

#### 3. The consultation

3.1 Public consultation took place over a 5 week period between 6 May and 10 June 2016. Approximately nine hundred and fifty (950) consultation documents were distributed to interested parties including: parents and carers, pupils, staff, local schools, the district and town councils, the local MP and the local community. The table below provides a list of consultees. The consultation was also made available on the Local Authority's website. A copy of the consultation document is provided in **Appendix 1** to this report.

3.2 The consultation document included a response form to assist and encourage people to give their views. Interested parties could provide a response to the consultation by

returning the response form attached to the consultation document, by completing it online, by letter or by email.

#### 4. Consultation events

4.1 A public information event was held at the school on Tuesday 14 June primarily to communicate information to stakeholders around the build element of the expansion prior to the submission of a planning application. The event was advertised via school book bags and flyers distributed to local households and the nursery. The event generated a turn-out of approximately 80 people, largely neighbours of the school. The architects, developers, the transport consultant and ESCC representatives were all available to discuss the plans and listen to comments and feedback.

#### 5. Consultation responses

- 5.1 By the end of the consultation period 71 responses had been received, of which 23 were completed on line and 48 forms were returned via freepost. In addition two emails had been received.
- 5.2 Respondents identified themselves as:
  - 32 parents/carers of a child at Meridian Community Primary School
  - 1 pupil at Meridian Community Primary School
  - 12 members of staff at Meridian Community Primary School
  - 3 members of the governing body at Meridian Community Primary School
  - 26 members of the local community
  - 8 other (Governor of another local school, local citizen, local resident, Saltdean resident, parent of ex pupil)
  - 1 incomplete
- 5.3 It should be noted that some respondents ticked more than one box when identifying themselves.
- 5.4 The public consultation document asked the consultees to respond to the following questions:
  - Question 1 Do you understand these proposals? The changes that are proposed have been clearly explained.
  - Question 2 Will the proposal impact on you and your family. If so, how?
  - Question 3 Please give us your views on the proposal and/or any options you think the Council should consider
- 5.5 The answers to these questions can be found in the detailed analysis of consultation responses in **Appendix 2** to this report.

#### 6. Key issues raised by respondents

- 6.1 In summary there was a mixed response to the consultation and the public information event. Those in favour of the proposal recognise the need for additional school places linked to new housing in the town and the benefits it would bring to an ever growing community. Those who raised concerns about the proposal did so generally for the following reasons:
  - Traffic congestion and parking

- Loss of playing field and facilities
- Peacehaven Heights Primary School should be enlarged instead
- A new school should be built in the town

I have recently joined the governing body at Peacehaven Heights as I have been impressed by the school and wanting to help contribute to my local community. The school has some fantastic opportunities, such as their pool and beach school and would be able to accommodate larger numbers at the two sites. Our recent Ofsted inspection showed that we are a good school and has improved and continues to develop greatly. I strongly propose that Peacehaven Heights is considered in place of Meridian for the expansion.

I feel the Council needs to have discussions with all the schools in Peacehaven, rather than focusing on just one school. All the Governors of the schools should be involved in such a major decision. As a former Head teacher working in Primary Education for 42 years, I think the proposal will make the school much too large for little children. I also have the following comments to make:  1. Why hasn't Peacehaven Heights School been considered for this development? It is much more central to the Town and its development would offer the Council several advantageous opportunities. There were 150 applications for entry to Reception in September 2016. There is currently a waiting list of 19 as all the classes are full. This is a popular, very well managed school providing a high quality education for all its pupils.  2. There would be sufficient room on the Junior site to further expand the school. Educationally, this makes excellent sense and would reduce the costs for running the school.  3. If the Infant site including the Nursery and Special Facilities Unit was housed on one site, it would free up the building on Edith Avenue for the council to consider a variety options.  4. The building could be sold at what I imagine would be a considerable profit, for housing or other purposes, thus defraying the costs of developing Peacehaven Heights school.  5. Alternatively, the Nursery and Special facilities Unit could remain at the school with any empty spaces being made available for holiday and Wrap-around-care which the Council has a legal obligation to support. It would also open opportunities for community use.  6. Roderick Avenue and Glynn Road already suffer immensely with parking at school times. The car park at Meridian can barely accommodate the current staff and is not viable for parents to park - or even to use as a "pick-up" point. Whereas at Hoddern Avenue there is specially designed area for parents to collect and drop off their children and the staff car park is much larger.  7. I realise that all the sc

# Public consultation on a proposal to increase the size of Meridian Community Primary School

## Consulation period Friday 6 May 2016 to Friday 10 June 2016

### What is the proposal?

East Sussex County Council is proposing to permanently enlarge Meridian Community Primary School from 420 places to 630 places from September 2018. Once enlarged, the school would be able to admit 90 children in each year group from Reception to Year 6.

We are consulting with pupils, parents and carers, staff, other local schools and trade unions. We are also consulting with a wide range of other groups including the Town Council, the District Council, the local MP, the Church of England and Catholic dioceses and the wider local community.

We welcome your views on this proposal. East Sussex County Council will take into account all the views put forward before a decision is made by the Lead Member for Education and Inclusion, Special Educational Needs and Disability on whether to continue with the proposal to enlarge the school.

#### Why do we need to enlarge Meridian?

There is an increasing demand for school places in Peacehaven and the surrounding areas. In recent years births in the Peacehaven area have risen from 175 in academic year 2003/04 to 254 in 2013/14. There are also plans to build around 900 new homes in Peacehaven and Telscombe between 2015 and 2030.

East Sussex County Council has a legal duty to make sure there are enough school places to meet current and future need. We wish to make the school larger from September 2018 to meet the increasing need for places.

#### How would the school be enlarged?

To support the enlargement of the school, the premises would be extended to provide additional classrooms and associated facilities. The building works would be planned carefully and contractors would work with the school to ensure that disruption is kept to an absolute minimum. The building site would be a secure area to make sure children, staff, parents and visitors to the school are kept safe.

The design and planning process for the building work would include a public information event, giving people an opportunity to view the plans, ask questions and make comments before a planning application is submitted. Concerns relating to parking and traffic can be raised at the event and as part of the planning process which is subject to a separate consultation.

#### How quickly would the school fill with extra children?

The school would grow gradually between September 2018 and September 2025 as it fills from Reception Year upwards. The school would reach capacity when it has 90 children in each year group from Reception to Year 6 – a total of 630 children taught in 21 classrooms.

#### What happens next?

This consultation closes on 10 June 2016. The Lead Member for Education and Inclusion, Special Educational Needs and Disability will consider the consultation responses and decide whether to take the proposal forward to make the school larger.

If it is decided to continue with the proposal we would publish a statutory notice in the local newspaper, probably in July 2016. This would be followed by another 4-week period of consultation (known as the representation period). A final decision on the proposal would probably be taken in September 2016.

If it is decided not to make the school larger other options will have to be looked at for the whole of the Peacehaven area to make sure there are enough places available. This may mean some children will have to travel further to school.
