Title of report: Appointments of Members to Committees, Sub-Committees, Panels and

Other Bodies

Purpose of report: To consider the allocation of places on committees, sub-committees,

panels and other bodies to the four party political groups, the Independent Democrat Group and independent members.

RECOMMENDATIONS:

The Governance Committee recommends the County Council to make recommendations to the County Council on the allocation to political and independent groups of places on, and membership of:

- (a) main committees in appendix 1 of this report;
- (b) other committees and panels listed in Appendix 2 of this report; and
- (c) Chair and Vice Chair positions on Scrutiny Committees and other Committees.

1. Supporting Information

- 1.1 In appointing members to committees, sub-committees, most panels and some outside bodies the Council must comply with section 15 of the Local Government Act 1989 and subsequent Regulations. These provide that places on committees must be allocated to political groups in proportion to the number of seats on the Council held by each group, unless there is agreement, without dissent, that the provisions of the Act should not be applied.
- 1.2 The allocation of places to party groups must, so far as is reasonably practicable, give effect to the following principles:
- (a) not all of the seats on the body can be allocated to the same political group;
- (b) where more than half the members of the Council belong to one political group, that group shall have a majority on all committees, sub-committees, etc;
- (c) subject to (a) and (b) above, the total number of seats on the ordinary committees (including sub-committees) allocated to a political group reflects that group's proportion of the members of the Council:
- (d) subject to (a), (b) and (c) above, the number of seats on each body allocated to a political group reflects the proportion of the seats on the Council held by the group.
- 1.3 The rules require seats to be allocated on a proportional basis "so far as practicable" and inevitably there must be some rounding up and rounding down. It is open to the Council to review the size and number of committees and sub-committees at any time.
- 1.4 Members of the Cabinet may not serve on the Scrutiny Committees or the Regulatory Committee and the Leader and Deputy Leader of the Council may not serve on the Standards Committee.
- 1.5 The Leader of the Council appoints the Cabinet and allocates portfolios to those Cabinet Members. Political balance provisions do not apply to the Cabinet

- 1.6 The principle in paragraph 1.2 (c) above applies to appointments to ordinary committees (including sub-committees). Accordingly, before considering the allocation of places to political groups the Committee will need to consider whether it wishes to recommend any changes in committees, including their size.
- 1.7 Following the Committee's meeting, the party group leaders and independent members will be asked to let the Assistant Chief Executive have nominations to fill the places on committees, subcommittees, panels and other bodies covered in this report provisionally allocated to their group. The nominations received will be circulated to members of the County Council on the day of the annual council meeting, for approval by the Council.

2. Allocation of seats

- 2.1 The Table in Appendix 1 outlines proposals in relation to the ordinary committees and subcommittees, their total membership and the number of seats on each to which the groups will be entitled following the principles set out in paragraph 1.2 above.
- 2.2 The allocation of seats to the Governance Committee has been proposed to take into account the importance of having one member from each of the three largest political groups. Membership of this Committee normally includes the Group Leaders.
- 2.3 The Committee is asked to consider the allocations in Appendix 1 and to make a recommendation to the County Council as to number of places on each committee to be allocated to each group or independent members.

3. Other Committees and Panels

- 3.1 There is no obligation in relation to other committees and panels to aggregate the total number of places and to adjust allocations so that the total number of places allocated to each group reflects its proportion of the members of the Council. It is proposed that places should be allocated on a proportionate basis, unless the Council agrees to waive the political balance provisions which has been the custom for certain panels over many years.
- 3.2 The practical effect of the proportionality rules for a committee, panel or group of members of any given size from 3 to 12 is set out in Appendix 2, together with the list of current committees and panels to which appointments will need to be made and their membership. Their terms of reference are set out in the Constitution.
- 3.3 The Committee is asked to recommend to County Council the number of places on the Committees and Panels listed in Appendix 2.

4. Chairs and Vice Chairs of Scrutiny Committees

4.1 The Council's Constitution provides that the Chairs and Vice Chairs of Scrutiny Committees and Audit Committee should be added together and the positions then allocated to groups in accordance to the number of seats they have on the Council. Within this allocation the Chair of the Audit Committee shall be appointed from the members of the largest Group not represented on the Cabinet. On this basis the allocation of the 8 places would be as follows:

Conservative – 4 Liberal Democrat – 2 Labour – 1 Green - 1 Independent Democrat - 0

RECOMMENDATION -

(1) To make a recommendation to the County Council on:

- (a) the appointment of four councillors to attend the Local Government Association's General Assembly;
- (b) which councillor should cast two votes;
- (2) To make a recommendation to the County Council on:
 - (a) the allocation to political and independent groups of places on the East Sussex Fire Authority and the appointment of twelve councillors to the Authority;
 - (b) the appointment of four councillors to serve on the County Councils Network Council;
 - (b) the appointment of a councillor to sit on the Coastal Issues Special Interest Group;
 - (c) the allocation to political groups of places on the Sussex Inshore Fisheries and Conservation Authority and the appointment of councillors to the Committee:
 - (d) the appointment of one councillor to serve on the South Downs National Park Authority;
 - (e) to remove the current appointments to the Conservators of Ashdown Forest and to appoint eight representatives to the Conservators of Ashdown Forest for a term of four years;
 - (e) the appointment of one member to serve on the Southern Regional Flood and Coastal Committee
 - (f) the appointment of one member to serve on the Joint Waste and Recycling Committee, and one substitute Member
 - (g) the substantive appointment of one member to serve on the Sussex Police and Crime Panel and one substitute member
 - (h) the appointment of one councillor to serve on the ACCESS Joint Governance Committee (Local Government Pension Scheme Investment Pooling)
- (3) To agree that where necessary recommended appointees are given authority to attend meetings or take actions prior to the appointments being confirmed at the Council meeting on 25 May 2021.

1. Background Information

- 1.1 The County Council is invited to appoint members (in some cases non-county councillors are eligible) to serve on a wide range of outside bodies. Appointments are normally made for the lifetime of the County Council. In the case of appointments being made now the term will be to the date of the annual council meeting in the next County Council full election year unless otherwise indicated, although in most cases it is open to the County Council to change its representation at any time by resolution.
- 1.2 Most of the appointments to outside organisations will be dealt with by the Governance Committee at its meeting on the 29 June. There are, however, some bodies where a decision cannot wait until then and these are dealt with in this report. Appendix 1 provides details of these organisations, the current appointments and any particular requirements relating to that particular body.
- 1.3 There may be actions or attendance at meetings required before these appointments are confirmed by the County Council on 25 May. In these cases that Governance Committee is asked to agree that these activities can be carried out as an interim measure prior to the formal appointments being made.

Title: Arrangements for the annual Council meeting

Purpose: To consider proposals in relation to the annual Council meeting

in the context of coronavirus (Covid-19)

RECOMMENDATION: The Committee is recommended to:

Recommend the County Council to agree to suspend such Standing Orders as is necessary to be able to defer items 15-19 set out on the Council agenda and to agree to those items being considered at the July meeting of the County Council in line with Public Health advice to minimise the length of the annual meeting.

1 Background

- 1.1 On 4 May 2021 the Committee considered ongoing meeting arrangements in the context of Covid-19 and the expiry on 7 May 2021 of the the Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority Police and Crime Panel Meetings) (England and Wales) Regulations 2020 (the Regulations) which expressly permitted the holding of virtual meetings during the pandemic. The Committee noted that legal action which sought to establish the legality of virtual meetings under existing legislation (the Local Government Act 1972) had not been successful. The court concluded that "once the Flexibility Regulations cease to apply, such meetings must take place at a single, specified geographical location; attending a meeting at such a location means physically going to it; and being "present" at such a meeting involves physical presence at that location". This confirms that virtual committee and Council meetings are not permitted from 7 May 2021 unless further legislation is passed.
- 1.2 In March 2021, due to the uncertainty regarding future meeting requirements, Council agreed to delegate authority to the Chief Executive to determine the venue for the Annual Meeting and to make the necessary arrangements accordingly.

2 Current position

- 2.1 The requirement to hold physical meetings from 7 May presents considerable challenges in terms of holding these with appropriate Covid-secure measures in place in line with national Covid-19 guidance and local risk assessment. These issues most significantly affect the holding of the annual Council meeting on 25 May due to the number of participants.
- 2.2 Following risk assessment of the options it is anticipated that the meeting will be held in the Council Chamber at County Hall, subject to a final decision being made. As reported to the Committee on 4 May, a significant number of mitigations would be in place to reduce the Covid related risks.
- 2.3 On advice from Public Health, one of the mitigations proposed is to minimise the length of the meeting as far as possible to ensure that councillors and support staff are not

in the meeting room for longer than is strictly necessary. It is therefore proposed to minimise the agenda to essential or statutory items only. The agenda for the County Council meeting is dictated by Standing Orders and includes:

- 1 To elect a Chairman of the County Council
- 2 To appoint a Vice Chairman of the County Council
- 3 Minutes of the meeting held on 23 March 2021
- 4 Apologies for absence
- To receive notice of the Returning Officer certifying the election of County Councillors for the various electoral divisions
- 6 Chairman's business
- 7 To appoint the Leader of the Council (and Chair of the Cabinet)
- 8 Record of delegation of Executive Functions
- 9 Report of the Governance Committee
- To allocate places on the following committees to political and independent groups.
- 11 To appoint members to other Committees and Panels.
- To confirm the continuation of the following bodies that have a fixed membership or to which members are appointed by the Chief Executive as the need arises.
- To appoint three members to serve on the Discretionary Transport Appeal Panel
- To appoint the Chairs and Vice Chairs of Committees
- 15 Questions from members of the public
- 16 Cabinet's priorities for the forthcoming year
- 17 Report of the Cabinet
- 18 Report of the Standards Committee
- 19 Questions from County Councillors
 - (a) Oral questions to Cabinet Members
 - (b) Written Questions of which notice has been given pursuant to Standing Order 44
- 2.4 In order to restrict the agenda to items 1 to 14 which must be considered by the Council at the annual meeting, it is proposed that the Standing Orders requiring others

matters to be considered (including 10.2, 41, 42, 43, 44, 45) at the meeting be suspended and that consideration of items 15 -19 be deferred until the Council meeting on 9 July which will take place after the proposed step 4 lockdown exit point on 21 June and by which time it is anticipated that the national review of social distancing will have concluded. Recent indications from Government are that the national lockdown exit timeline is likely to proceed as planned and that social distancing requirements are likely to be relaxed. This would make it possible to hold a Council meeting in more usual circumstances in July.

3 Conclusion and Reason for Recommendation

3.1 In order to hold a physical Annual Council meeting in line with Covid-19 guidance and Public Health advice, a range of risk mitigations will need to be in place. Minimising the time spent by councillors and support staff in the meeting room is a significant mitigation in relation to the risk of Covid transmission. The Committee is therefore recommended to recommend the County Council to agree to defer consideration of the items as set out in paragraph 2.4 above.
