Reasons

27.3 The asset was formerly used as a grounds maintenance depot, and forms part of a larger site owned by East Sussex College, Eastbourne. The College has secured outline planning permission, and the Council supports the College's approach to maximise the value of the Site which may take the form of a joint sale or a surrender of the lease to East Sussex College, Eastbourne.
