**Constitution of the East Sussex
Standing Advisory Council on Religious
Education (SACRE)**



Revised March 2022

Introduction:

A SACRE is a statutory body which is established by the local authority to carry out a range of duties associated with Religious Education and Collective Worship in schools. The legislation that established the role and function of SACREs is laid out in the Education Act of 1996 (sections 390-397). SACRE reports annually to both children's services and the full council about its work and progress.

Composition:

SACRE shall have a maximum of 30 voting members and up to 3 non-voting co-opted members.

Clause 390(4) of the Education Act 1996 requires that the Local Authority appoints members representing the following groups to constitute the SACRE. The maximum number of members in each group is indicated below:

- Group A - Such Christian and other religious denominations (other than the Church of England) as in the opinion of the Authority, will appropriately reflect the principal religious traditions in the area. **15 (11)**
- Group B - The Church of England **4 (4)**
- Group C - Such associations representing teachers as, in the opinion of the Authority ought, having regard to the circumstances of the area to be represented. **6 (5)**
- Group D - The Authority (appointed in conformity with the political balance). **5 (5)**

Total number of voting members **30**

Non-voting co-opted members. Placed in Group A (to be discussed by SACRE) **3 (1)**

Advisers to SACRE **2**

Clerk **1**

Chair and Vice Chair:

- A chairman and vice chair will be elected on an annual basis, usually at the AGM which will be in the autumn term usually following East Sussex County Council elections.
- The chairman will be an elected member of the County Council. The Chair and Vice-Chair will be elected at the Annual General Meeting.
- The Chair and Vice-Chair person are elected for a period of 4 years and can be re-elected.
- Nominations for the position of chair and vice chair shall be submitted to the clerk 7 days in advance of the AGM.
- Representatives who continue to be members of SACRE are eligible to be elected as vice chair.
- In the event of an equal number of votes for the position of vice chair the chair of SACRE will have the deciding vote.
- The Chair will be responsible for convening and chairing the meetings in line with the constitution and any other appropriate guidance issued by the local authority.
- The Chair of East Sussex SACRE or his/her representative will represent East Sussex SACRE on any local or national bodies as appropriate.

Membership:

- SACRE meetings will be attended by the clerk, the RE adviser to SACRE and, from time to time, other East Sussex education advisers to promote effective communication with

the School Improvement Service. SACRE meetings are open meetings, so that members of the public may also be present.

- The main Christian denominations and groups will be offered representation and other world faiths that are mentioned in the East Sussex Agreed Syllabus or found locally: Bahá'í faith, Buddhism, Hinduism, Islam, Judaism, and Sikhism.
- All members, including the chairperson, will serve for up to 4 years, after which they may be re-elected by the nominating body for a further 4 year period(s).
- All members must be nominated by a representative body. This should be a local body, wherever possible. In exceptional circumstances this may be a national body. Members will normally be expected to live or work in East Sussex.
- Any member who does not attend 3 consecutive meetings without valid reason will be deemed to have resigned and the nominating body will be asked to name a new representative.
- Where a substitute is to be sent then the clerk needs to be notified in advance of the meeting. Only named substitutes may attend and vote on behalf of a representative group and they should be fully briefed by the member.
- SACRE members may suggest groups without representation on SACRE which they think should be included. Groups with an interest in the work of SACRE may themselves offer a representative. Decisions about allocation of places for co-opted members will be taken by the SACRE.
- The quorum will be an attendance from each representative group (A-D), as actually constituted, of one third of the members of that group (to the nearest whole number).
- Where the SACRE is not unanimous on a decision, a majority from a group vote will be taken with each of the 4 representative groups having a single vote, which vote need not represent a unanimous decision by that group. Dissenting views may be recorded. In the event of a casting vote being required, this will be given by the chairman.
- SACRE will seek to ensure that the membership of SACRE is as diverse as possible and representative of the spectrum of faiths and beliefs in East Sussex.

Duties:

- SACRE will **advise the local authority** on matters pertaining to the teaching of RE and collective worship as laid out in the statutory responsibilities for the teaching of RE and requirements for collective worship. The local authority may ask SACRE to report on particular aspects in general relating to these responsibilities.
- More specifically SACRE is responsible for:
 - developing the local agreed syllabus for the teaching of RE
 - aspects of continuing professional development and training relating to RE
 - teaching methods
 - matters relating to collective worship
- SACRE works with the local authority and its partners to **monitor** the implementation of the local agreed syllabus
- SACRE will **review the local agreed syllabus** at least every 5 years and will convene an Agreed Syllabus Conference for this purpose according to the statutory guidance.
- Have an agreed process for **Determinations** in relation to collective worship and undertake these as needed. This is the process where SACRE decides whether collective worship in a community or foundation school of a religious character needs to be of a 'wholly or mainly of a Christian character' and whether this applies to the school making the application. The East Sussex Determinations form shall be used for this purpose and any decision reviewed after five years.
- SACRE will produce an **Annual Report** relating to how it has carried out its duties and progress against the priorities and the development plan. NASACRE guidance will be used to inform the production of the Annual Report. Typically this will be completed by the 31 March each year.

- SACRE recognizes that academies may choose to follow the local agreed syllabus or one of their own choosing. Academies will be encouraged to follow the local agreed syllabus along with their community counterparts. Determinations for academies are not made by SACRE but are made directly to the Secretary of State.
- SACRE will be affiliated to the National Association of Standing Advisory Councils for Religious Education (NASACRE).
- Where possible the Adviser to SACRE will be a member of the Association of Religious Education Inspectors Advisers and Consultants (AREIAC).

Working Groups:

- SACRE may require the formation of working groups to undertake specific tasks on its behalf.
- The remit and tasks of any working groups shall be decided at SACRE.
- Working groups will be dissolved once their remit is complete.

Quorum and Voting:

- Quorum shall be agreed if there are at least 7 members present with at least one representative from each of the 4 groups. If the meeting is not quorate then business cannot proceed.
- Any questions requiring decisions by SACRE shall be made by all members with at least one member of each group present and each person shall have a vote. Co-opted members are not able to vote.
- Decisions are reached by a simple majority vote in which each member has a single vote.
- In the event of a tied decision the chair of SACRE shall have the casting vote.

Administration:

- The local authority makes the necessary arrangements for a Clerk to SACRE to support all administrative matters on behalf of the board.
- The Director of Children's Services is entitled to attend or a representative of the Director and shall be present throughout the meetings and able to offer support and guidance.
- SACRE shall meet at least three times a year and the agenda and papers will be circulated at least a week prior to the meeting.
- Other items may be added as they arise during the course of business or as AOBs.
- Minutes will be agreed by the Chair and circulated within 14 days of the meeting. They will be approved at the next SACRE meeting. The minutes will then be available on CZone and will be available to the public upon request.
- Meetings will be held in public unless statutory obligations deem otherwise.
- All meetings will be made as accessible as possible.

Visits:

On occasion SACRE members may have the opportunity to visit schools, this is a privilege and SACRE members are there as invited guests, not inspectors. When an invitation to visit a school is received by a SACRE member, they are asked to:

- Inform the clerk of the visit dates and arrangements
- Ensure that you are respectful of all faiths, religions and ethical beliefs
- Avoid being critical or imposing your own views

- Be encouraging and informed about the developments and priorities of the East Sussex SACRE
- Be supportive of the school and their endeavours to deliver high quality RE and comply with the statutory requirements around RE and collective worship
- Where any issues arise be sure to discuss these with the Chair of SACRE and the Adviser to SACRE so that they may be resolved

Accountability:

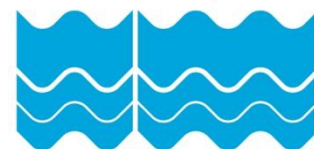
- East Sussex SACRE is fully accountable to East Sussex County Council.
- ESCC will provide such budget that will allow East Sussex SACRE to carry out its duties in full.

Code of Conduct Guidelines for attendance at meetings

- Respect the faith, belief and practice of those present
- Listen to what other people have to say; everyone's contribution is relevant
- Comments should be addressed through the chair
- Wait for someone to finish speaking before you begin and give people a chance to respond
- Be assertive but respectful of others
- Accept differences of opinion and respect each other's views
- Do not use abusive or discriminatory language or say things that could hurt others
- Try to encourage everyone in the group to participate fully by giving them a chance to speak and by making them to feel comfortable and supported
- Maintain confidentiality when requested so that people may speak openly
- Be clear when you speak, avoid using jargon if you can and be sure to explain any initials and terminology so that others feel included
- Aim to have a discussion, share ideas, ask question and follow on from what others are saying rather than making a speech
- Be aware of and be courteous to people around you
- Keep mobile phones on silent unless in an emergency
- Recognise that all present have a right to respect for their individual beliefs
- If anyone deliberately misrepresents or disparages other people's beliefs and practices they will be asked to leave the meeting

Title:	SACRE Budget 2021- 2022 and outline Budget Plan 2022 - 2023
Purpose:	To advise the East Sussex SACRE of the budget position for 2021- 2022 and and outline budget plan for 2022 - 2023

Recommendations:

- SACRE are asked to approve the budget spend for this year and the outline plan for next financial year.
- Agree to make a case for an ongoing budget share of £15,00 per annum going forward to support high quality RE in East Sussex.

1. Background

The annual budget allocation for SACRE in recent years has usually been between £7,000 to £10,000. This year and next financial year the allocation is agreed to be £15,000 to reflect that over the next two years there is funding and work required to support the revision of the Local Agreed Syllabus.

6 Understanding Christianity subsidy explained:

With regards to Understanding Christianity under Syllabus model B, there is now a positive change around the interpretation of eligibility for the allocation of funding. We can now engage the following schools within the UC subsidy, Foundation, Academy and Free schools, this would be subject to an individual school check which we would carry out.

This makes a significant difference when engaging with Syllabus model B, as the original outline proposal was based on 44 community schools taking part with the UC training and receiving a 71% subsidy, this could be increased to 122 schools, which leaves the 44 Voluntary controlled and the 22 Voluntary aided schools outside of the subsidy. However, if these schools wished to engage with UC we would support them with a subsidy provided by RE Today.

6.1 Costs for Understanding Christianity:

- The funded schools would pay £60 towards the total cost of £210 for the training and their UC folder
- The unfunded schools would pay £60 towards the total cost of £210 for the training + £75, which is the cost of their folder, the remaining £75 would be subsidised by RE Today, making the total cost to each school £135.

7. Launch Event Options for purchasing the schemes of work (optional):

The schools will have the opportunity to purchase the scheme of work for the following:

- Primary schools – Gross cost is £300 applied discount £140 = net cost of £160
- Secondary schools – Gross cost £165 applied discount £77 = net cost of £88

The hub was advised that we are going with the RE Today model for the new syllabus. Stephen Pett has emailed some titles of units to the hub members to help with planning for next term.	
3.3	CRa is in contact with Stephen Pett re the syllabus launch date of 29 March 2022, 09.15 – 15.30, this event will be held remotely to allow for more attendees. The plan is to run a primary and secondary session together in the morning and then separate primary and secondary groups in the afternoon.	

3.4	Cllr Galley asked if Stephen Pett could send the full content of the units to the hub members? This would give the opportunity for any comments. CRa confirmed she would contact Stephen.	CRa
3.5	PW asked for an update on the situation with the KS4 element of the syllabus. CRa advised that we will still encourage schools to opt for GCSE, and confirmed she is in dialogue with Stephen Pett to develop the KS4 unit alongside the Agreed Syllabus. The core curriculum will be ready for the launch.	
3.6	CRi updated the meeting on the Primary Network meetings. A network meeting was held on 29 September with 37 attendees; Ruth Flanagan spoke on World Views and received very positive feedback. Ruth Flanagan will be attending a primary network meeting again on January 26 to lead on a session on RE and Research.	
3.7	CRi advised that she had been contacted by some maintained schools and academies to ask if they need to follow the agreed syllabus as they had signed up for Discovery RE; CRi has sent the legal requirements to the schools. 4	Feedback from World Views, NASACRE on-line training session	
4.1	Cllr Galley led on this item. The NASACRE training sessions were working extremely well due to remote working. Ruth Flanagan had spoken at the NASACRE session on 10 November re World Views. Cllr Galley gave his opinion that World Views is a fascinating subject but is not convinced that this is RE and worries that the understanding of religion will be 'watered down'.	
4.2	Discussion and debate amongst the group followed, the key points were: <ul style="list-style-type: none"> (i) EC – Perhaps we should have religion as the focus but embrace others that do not have a religion. (ii) BB – Worldviews allows children to understand the relevance of RE and has his support. (iii) CRi – Worldviews does not undermine faiths; it is very much centred around debate and discussion to make things relevant to students. (iv) NW – We need to be careful in limiting the teaching of religion to children; we must be open to other ideas and let people have the freedom to make their own minds up. All religions are inter-linked. (v) RR – We should be trying to help children understand what they believe; Worldviews seems a bit “woolly”. (vi) PW – Finds the concept of Worldviews confusing. We need a much more informed decision. (vii) Rev JS – RE works best in a philosophical/ethical way, if Worldviews are also using deep questions then that is fine. (viii) JG – From a primary HT point of view, humanism is becoming more of a force. (ix) AF – In our catholic schools we have a very prescriptive curriculum and is currently being looked at the Bishop’s conference to link with Worldviews.

Faith and Belief in the 21st Century The new Agreed Syllabus for RE for East Sussex 2022-2027

Introduction:

Colleagues across East Sussex, led by SACRE (Standing Advisory Council for Religious Education) have been working over the last two years to plan for and review the Agreed Syllabus for RE. It is a statutory requirement that each local authority establishes an Agreed Syllabus Conference to lead the completion of the review process and to agree a new syllabus. In East Sussex we have consulted widely with schools, faith groups, parents and students before arriving at an agreement to work with a national organisation, RE Today, to support us in developing the new syllabus. The new syllabus has now been formally adopted and will be implemented from September 2022 for first teaching. The first year is always a transition year and schools may choose to work with a staged process for implementation in the first instance. We are very excited to have a new, relevant and up to date syllabus for all schools and academies in East Sussex that we believe is a significant step change from our current syllabus.

Not only do we have an exciting new syllabus, but we have a support package and additional materials that we are offering to schools. In this document you will find your quick guide to the new syllabus and to the key dates you need to note and book so that your school is fully prepared for teaching from September 2023.

Agreed Syllabus;

The new syllabus will be available from the launch event and will be issued to schools in electronic form and hard copy, one per school, for every school and academy. This gives the outline of the legal teaching requirements, suggested content, assessment and timings.

The 5-year licence for the syllabus has been paid in full for every school through the SACRE budget. This is a significant investment and one that we hope all schools and academies will take full advantage of to enable you to meet the legal requirements in a vibrant and engaging way for all pupils.

Schemes of Work:

To support the implementation of the syllabus detailed schemes of work are available for schools to purchase when they attend the launch event above. *Please note these are only available at a reduced rate where schools send a representative to the launch event.*

Primary Schemes of Work for KS1 and KS2: Full cost is £300 applied discount £140 = *discounted cost for schools attending the launch of £160*

Secondary Scheme of Work for KS3: Full cost £165 applied discount £77 = *discounted cost for schools attending the launch of £88*

The units of work offer substantial guidance on teaching and learning, with a range of thoughtful and creative activities you can use to plan your pupils' learning journey in response to the syllabus key questions. The units exemplify the syllabus planning approach so that you can create a coherent curriculum for your pupils.

Sessions will outline the wider context for RE and provide some inspiring and practical ideas for the classroom. There will be plenty of resources and ideas to take away and use in your classroom.

9.15-9.30 Welcome and Introduction to the day

9.30-11.00 Session 1: The intent of the new Agreed Syllabus: belief, impact, connections

This session will consider the place, purpose and value of RE for pupils, highlighting the developments and opportunities in the new syllabus. It will demonstrate how to use the syllabus to plan and teach engaging, thoughtful RE.

11.30-1.00 Session 2: Implementing the Agreed Syllabus

This session will offer examples of excellent teaching and learning ideas, based on the syllabus, with a focus on creative strategies that enable pupils to recall their learning.

Welcome and Update from the Chair

Welcome to this edition of the NASACRE Briefing.

This term has been one of consolidation and renewal for NASACRE and for many of its member SACREs. Consolidation, as we have secured our CPD programme for members, re-established our thriving partnerships with other RE associations, and obtained helpful advice from the DfE. Renewal, as like so many other education networks we have taken inspiration from teachers and other professionals as they rose to the challenges of the new academic year in these tricky times.

The [NASACRE report](#) on SACRE funding remains a source of discussion locally, and at our executive committee meetings and in other RE networks. She was passionate about the subject, and about teaching, a deep thinker and a very practical support in so many settings especially in the world of websites and IT. Her sense of humour, hospitality, honesty and kindness will be missed, and so will her wonderful wildlife photography.

NASACRE needs you to consider how members of SACREs might help the association in the future. Our executive committee still needs a Vice-Chair, who will then become Chair, and we will be actively and strategically advertising this vacancy between now and our AGM in May. Sad news

We are sorry to inform SACREs of the untimely deaths of Ted Cooke, Chair of Waltham Forest SACRE for many years and Sharon Artley, a former member of NASACRE Exec and an RE Consultant. Both will be sadly missed in the world of RE and SACREs.

New website

An overhaul of the NASACRE website is underway with the aim of bringing a fresh design and a more contemporary feel to it.

Content is being streamlined so it's easier to use, combining sections such as the SACRE Contacts Directory and Annual Reports, thereby reducing the number of clicks a user needs to make. Some older things will be archived, but still searchable, and there will be more resources available to subscribed member SACREs at the click of a 'Members' button.

We're also looking at bringing a more 'community' feel, by introducing a section for shared resources and links with NASACRE partners such as the REC.

The new site is due to go live soon, with the intention that webpages will continue to be developed thereafter. From the launch onwards, user feedback will be essential so that the website can continue to evolve.

Conference 2022 - Ambitious SACREs

Taking place in Birmingham on Monday 23 May, this conference will provide an opportunity for SACRE members to engage in discussion around issues of RE and Collective Worship. Keynote speakers will be Sarah Lane-Cawte (new Chair of the REC - Religious Education Council), HMI Richard Kueh (Ofsted) and David Hampshire, a previous chair of NASACRE, who will present the analysis of the most recent (2021) SACRE annual reports.

Additional sessions will look at the new SACRE audit tool, Westhill award winners, the LAN report (see briefing item below) and other topical issues of interest to SACREs.

LAN (Local Area Network) report

Still Standing – the REC Local Area Network Report is now live [here](#).

The report asks SACREs to consider the following points:

1. Reviewing SACRE membership in partnership with the LA to ensure that it is representative of the local community, and supports the religions and worldviews included in the Agreed Syllabus. Having a diverse range of voices with specific roles on SACRE is essential if an LA is to be able to discharge its legal responsibilities. SACREs can start the process of working with their LA to update membership now. This may require a change to the constitution or terms of reference; the

LA legally approves your members and there is nothing in the present legislation that would hinder this.

2. Continue to build local partnerships with the LA to ensure necessary funding.
3. Within the present legislation regarding their ability to widen their membership, the CoRE report helpfully suggests SACREs think about adding to their membership - if they haven't done so already - education departments at museums and universities, local ITT providers, local RE CPD providers, training school hubs, parents, governors, pupil voice, academies and free schools, to name but a few possibilities. Widening representation and local buy-in strengthens the work of high quality RE in schools.

Claire Clinton, the report's author, believes that there are some useful documents developed by SACREs who participated in the project, for other SACREs to use in their work, including

- An audit tool for Agreed Syllabus reviews
- A simple participatory action research template
- A membership tool

NASACRE hopes that there will be an opportunity for SACREs to find out more about these tools and discuss the impact of the report at our (hopefully!) face-to-face May 2022 conference in Birmingham (see conference item above).

NASACRE is now encouraging and inviting individual SACREs (or SACREs in partnership) to apply for a Westhill/NASACRE Award for 2022-23. Awards of up to £4,000 may be applied for via the [application form](#) on our website.

Projects should offer pupils the opportunity to engage in compelling learning experiences in RE (or collective worship), within the broad theme of "Education into Diversity", understood as diversity across the spectrum of faiths and worldviews.
