Notice under The Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

On the 20 October 2020 East Sussex County Council intends to hold a meeting of the Lead Member for Resources at which the following item will be considered: Former Wadhurst Household Waste Recycling Site.

The purpose of the item is:

Following both closure of the sate in 2018 and a review of best value options together with test marketing a formal surplus declaration is now required to enable its future disposal.
