Purpose of This Document

To collate and review the information and feedback from the demonstration of the Foam Stream technique undertaken on the 25th of January 2022.

To understand the benefits and restrictions of using Foam Stream as an alternative weed maintenance technique.

To present the outcome and conclusions made from this trial.

Demonstration Overview

Contact was made with Lewes District Council (LDC) to arrange the demonstration. LDC currently use Foam Stream on their parks, recreation grounds, and property. Foam Stream is a low-pressure process, combining heat with biodegradable foam to kill off weeds.

The team met with a LDC representative, the Idverde team (contractor) and the UK Sales Manager from Weeding Tech.

An overview was given of the machinery available (see appendix A3). A demonstration was then undertaken at their Newhaven Depot (see appendix B3). The team then relocated to Mayfield Avenue, Peacehaven a highway location suggested by the highway stewards, to provide a demonstration of highway use (see appendix C3).

Benefits Noted

- Can be used in any weather.
- It doesn't use chemicals.
- It can also be used for graffiti removal.
- It is great for killing moss etc on hard surfaces / play area surfacing.
- Eliminates the need for ongoing operator certification, full protective clothing, and specialist training.
- Is a consumable blend of biodegradable natural plant oils and sugars, so it is safe to use around people, animals, delicate ecosystems and waterways.

Issues Noted

- The L12 machine has 1hr 30 Minutes on the trigger however would take around 1hr to refill water tank.
- Would need fire hydrant license to refill or alternate locations to source water.
- Will need 2 staff members one to move vehicle and one to spray.

- Slow moving and Noisy.
- Hose trip hazard potential need to close pavement.
- Applications needed week 1 week 6 and week 12. Would need a total of 3 applications.
- Petrol engine & diesel boiler.
- Needs to be mounted on a flatbed truck depending on machine.
- Would need more than one machine to maintain the county.
- LDC also supplement the use of foam stream with hand pulling and strimming of weeds if a quick response is required.
- Traffic management would be required when using this method on some parts of the network, high speed roads for example.

Calculations

Time

The highest output for Foam Stream is the L12 tank at 700m2 per hour for low vegetation. This equivalates to 5,600m2 per day compared to 35,200m2 with Gallup (glyphosate based weed killer).

However, the device needs to refill on average every 1hr 30 mins with continuous use which takes around 1 hour, this would reduce the output to 3150m2 due to needing to refill three times a day at least.

It would therefore take just over 11 days or 11 machines to mirror the efficiency of one day of Gallup application. Additionally, it should be noted that at least 2-3 visits would need to be undertaken with Foam Stream.

Therefore, to apply weed control using foam stream at the same rate over the season would require 11 machines with 2 persons crews if only one application is undertaken. However, to achieve the recommended 3 applications of hot foam per season it is estimated 30 machines and crews would be required to cover the network.

Cost

The total cost of weed control across the whole County in the Highways contract is approximately £55,000 per year.

Sussex Rail (the sub-contractor for weed control) provided an estimate for using Foam Stream, in the Hastings area of £90,340 per application. This is five times the current cost for Hastings weed control of approximately £18,000. This is for approximately 800 miles of kerbs and channels in Hastings.

The total length of all the kerbs, channels across the rest of the County comes to 1,915miles (excluding Hastings).

Therefore, to do the rest of the County (1,915 miles) is estimated to cost £216,250 for a single application.

If we include Hastings the cost for a single foam treatment across the whole County is estimated to be £306,500. If the recommended three treatments are applied the cost is estimated to be £919,500.

This estimate does not include costs for any traffic management required on certain parts of the network.

It should also be noted at the present time there is insufficient capacity within this industry at this time to deliver such a large programme of works using this method.

Outcome & Conclusion

While this method of weed control appears to work well within the confines of parks and open spaces it is was concluded by all parties involved in the trial that this method would be difficult to scale up and apply to a large highway network.

Therefore, at present Foamstream is not a viable option for highway maintenance due to the scale and complexity of the network. The costs associated with this technique are also not achievable within the current budget.

Opting out of Weed Maintenance – Volunteer Guidance & Agreement

Once your application for opting out has been accepted the following document will need to be signed.

Nature of Work

The work which will be undertaken is the removal of weeds and plants from the footway on the agreed road. The volunteers are not permitted to work on the carriageway. The arisings from these works are to be disposed of by volunteers.

These works are only to be undertaken in the agreed area on the footway. No grass cutting of verges or hedge cutting will be undertaken.

Power tools are not to be used.

Please note that our insurers do have the right to refuse cover if they believe we are operating outside of our own agreed risk guidance and therefore it is important to follow the agreed rules/code to ensure we minimise any losses.

Any volunteers who help out with the weeding do so expressly on the basis that the lead volunteer does not assume a duty of care towards their fellow volunteers and will not be held personally liable in the event that an injury or loss occurs to another volunteer. Each volunteer must take responsibility for their own personal health & safety and if in any doubt should raise queries or issues with ESCC.

Why do we maintain weeds?

Weed maintenance on the highway is necessary for the following reasons:

- Weed growth in road gullies and channels can slow down and prevent our drainage systems from working
- Weeds can damage paved surfaces, displace kerbstones and crack walls making maintenance difficult and costly.
- Weeds can create trip hazards
- Weed growth can trap litter and debris.

Volunteers

The Lead Volunteer (LV) cannot work alone and will need to be supported by other volunteers. All volunteers will need to complete the Volunteer Registration Form found at **Appendix A** and the LV will need to submit these signed with the signed agreement to: contracts.managementgroup@eastsussex.gov.uk

Training for Volunteers

The LV and 2-3 other volunteers (dependent on size of group) will need to undertake Health and Safety training provided by ESCC to supervise the works.

They will then be responsible for disseminating it to the other volunteers ahead of any works taking place on the highway.

This will be arranged once all documentation has been signed and received.

Guidance for Volunteers

- Make sure you know the locations and requirements of the task and understand the conditions under which they are to be carried out including the acceptable standard and finish. This can be found within this document.
- All volunteers must start and finish the works at the same time.
- Ensure that all volunteers are well briefed and that they are aware of and follow statutory regulations and guidelines.
- Ensure that all volunteers have read this document.
- Know how to deal with enquiries and how to report accidents or incidents to ESCC.
- Ensure you understand the risk assessment and method statement as outlined in Appendix B.
- Ensure Volunteers are working as a group of 2 at minimum.
- Volunteers are only permitted to work on pavements and footpaths.
- Volunteers are not permitted to work on the vehicular carriageway itself.
- Volunteers should not be put, or put yourself, at any further risk than a pedestrian would by using the pavement.
- The ground must not be broken under any circumstance.
- Volunteers are not permitted in any circumstances to work at height.
- Volunteers are not permitted to use power tools.
- Volunteers are not permitted to work alone.
- Volunteers must not undertake any task that may exacerbate any health condition.
- Volunteers are not permitted to undertake any maintenance on grass verges or hedges.

ESCC reserves the right to require volunteer activities to stop and may withdraw permission if the tasks are not being carried out appropriately or if any of the council's conditions or restrictions are not being complied with.

Please note, if the conditions outlined in this agreement are not being followed, volunteers will not be covered by East Sussex County Council insurance.

Preparation

 The Declaration of Work Form (provided separately to this document) must be completed at least 2 working days prior to any works being carried out. This also must be submitted each time work is to be undertaken.

During

- Before any work begins the On-Site Work Form (provided separately to this
 document) must be completed. This must be completed each time works are
 carried out.
- Area to be maintained is thoroughly checked for animals, nesting birds and other obstructions before commencing.
- Area should be checked for hazardous waste. Avoid clearance close to potentially hazardous waste. Notify your relevant District or Borough Council if waste is found.

- Consider what PPE is needed for example; gloves, boots, hand cleaning material, first aid kit. ESCC will provide hi-viz waistcoats, gloves and goggles.
- Always be aware of your surroundings.
- If at any point you feel it is unsafe to continue, you must stop.
- If there is an **incident on the Highway**, no matter how minor, volunteer tasks must stop and the incident must be reported as soon as possible to the Highways Contact Centre (on 0345 608 0193) who will notify the appropriate officers.

Completion

- Check that the area or path is clear of obstruction, in particular, any cut stems that may have sprung up when cuttings have been removed.
- All waste or arising's must be removed from site and disposed of appropriately and in accordance with relevant legislation.
- Ensure all volunteers agree works are completed and leave site at the same time.

Notifying ESCC

Once works have been completed the LV must notify ESCC by emailing the **On-Site Work Form** to: Contracts.managementgroup@eastsussex.gov.uk within 2 working days.

Monitoring

The council regularly monitors the condition of highway assets throughout East Sussex. Contract and Commercial Supervisors (ESCC staff) or Commercial and Cost Control Officer (ESCC Staff) will carry out spot checks.

If we notice that weeds are at an unacceptable level or pose a potential safety hazard, then we'll get in touch with the LV to discuss how to remove them and offer support as appropriate. If the weeds remain after an agreed period then, as a last resort, the road will be put back on the glyphosate spraying schedule until a suitable alternative can be found.

If ESCC see or have reports that the volunteer group is not working safely, the volunteer group will not be covered by East Sussex County Council Insurance, asked to stop any works and the area will be put back on the glyphosate spraying schedule until a suitable alternative can be found.

It is imperative that all forms are submitted within the timeframe given. If the conditions outlined in this agreement are not being followed, volunteers will not be covered by East Sussex County Council insurance.

East Sussex County Council staff will then undertake checks after the works have completed.

Complaints and Customer Contact

Complaints and customer contact will be dealt with through our Highways Contact Centre.

If we receive an increased level of complaints about the weeds on the agreed road this will trigger a review as set out above in the monitoring section.

Method Statement

Introduction.

During the weed removal process, volunteers will be required to remove weeds from gaps between the footway and adjacent property and or the footway and the curb or other edge of carriageway. Where the footway comprises slabs or other block materials joints between individual footway components may need to be cleared.

After preliminary investigations, the most effective and safe form of removal will be applied. Physical removal of the plant and disposal will be required. This should take the form of handheld tools; long handle hoes or similar are the recommended implement.

After removal it is the volunteer's responsibility to ensure all recovered material is disposed of in suitable, safe way and in accordance with the relevant legislation.

Method.

Only work in agreed areas must be carried out.

Appropriate PPE must be worn at all times.

Sturdy footwear ideally with a reinforced soul and steel toe cap should be worn.

All work should be undertaken in pairs with one volunteer maintaining a safety observation role ensuring neither a volunteer or the public are put at unnecessary risk by the weeding activity. If a member of the public approaches the work area, work must stop and the resident allowed to pass in safety and then continue once it is safe to do so.

All tools should be checked for safety at the start of every shift and at least once, ideally more times during the day. Any tools not in a safe condition should be removed from the work area, disposed of and replaced as soon as possible. Any tools not in use must be stored away from the work area so as not to present a risk to volunteers and the public.

All arisings must be bagged at regular intervals and the bags moved to a safe location away from the work area so as not to become a trip hazard to volunteers or the public. Care should be taken when lifting any bags of waste, follow the guidance below for the safe lifting of heavy loads, never lift more weight than you can comfortably carry.

Opting out of Weed Maintenance Application Form

In the interest of testing alternative solutions to using glyphosate on the public highway, ESCC Highways are trialling three different approaches to maintaining weeds in 2022. These are:

- Foam Stream
- Reactive Weed Maintenance
- Opting out of weed maintenance

These will be undertaken in select areas.

This form is to apply to take part in the trial for opting out of weed maintenance for 2022.

Why do we maintain weeds?

Weed maintenance on the highway is necessary for the following reasons:

- Weed growth in road gullies and channels can slow down and prevent our drainage systems from working
- Weeds can damage paved surfaces, displace kerbstones and crack walls making maintenance difficult and costly
- Weeds can become trip hazards
- Weed growth can trap litter and debris.

How to apply:

Please note, for safety we can only allow roads which follow the below criteria to opt out:

- Road must be 30mph or below
- Road must not be an A or B road
- Road must be a residential road
- Road must have low traffic
- Road must have footpaths
- Road must not include sharp corners, bends or steep hills

Lead Volunteer

A representative from the road will need to sign up to become Lead Volunteer. This person will be the point of contact for ESCC if there are any problems, such as reports of overgrown weeds from the public. They will also receive training in Health & Safety and Risks along with 2/3 other volunteers, who will all be responsible for disseminating to the other volunteers. Please see the Opting Out Volunteer Guidance & Agreement for further responsibilities. **See Appendix A** for application form.

Road Residents

The Lead Volunteer will need to get at least 75% of the residents living on the road signed up to opting out of Weed Maintenance for the trial to progress. **Appendix B** provides a form which will need to be submitted to us.



ESCC Review

Once we have received all the documents, they will be reviewed, and contact will be made with the Lead Volunteer to advise whether the application has been accepted.

Volunteer Guidance & Agreement

Please ensure you have read the volunteer guidance & agreement document before completing this application form.

If your application is accepted the agreement will need to be signed by the Lead Volunteer and other volunteers. The Lead Volunteer will be responsible for getting the signatures.

Most of this training is just common sense and things you will already consider and do.

This training is important as it helps us keep you safe and also allows ESCC insurance to cover you whilst volunteering.



What you will be doing.

As outlined in the agreement, the work which will be undertaken is the removal of weeds from the footway on the agreed road. These works are only to be undertaken in the agreed area on the footway. No grass cutting of verges or hedge cutting will be undertaken.

- Volunteers are not permitted to work on the carriageway.
- The arisings from these works are to be disposed of by volunteers.
- Power tools are not to be used.

Volunteers must follow the agreement, if you don't, East Sussex County Council will not be able to insure you.

Risk Assessment

We all have an inbuilt ability to carry out risk assessments and we do it right throughout the day!

Before you cross the road, you look to see what traffic is on the road. You determine how fast the vehicles are going and how far away they are. You look to see how wide the road is and you determine your ability to cross the road; whether you can walk or you are on crutches and have to hobble across.

This is a simple example of risk assessment: you looked at the hazard (crossing a public road) and, based on the factors related to this hazard (number of cars present, speed of cars, width of road and ability to cross), you assessed the risk to you if you were to cross.

When it comes to volunteer weed maintenance all that is needed is to take that inbuilt ability you have to do risk assessments and apply it to your work activities.



Hazards



A hazard is something that has the potential to harm you.



In its simplest form, identifying hazards involves asking yourself "Where can people come to harm?"



Example: When crossing the road, a passing vehicle is the hazard.



Risk



The next thing you need to know about is risk. Can someone be harmed by the hazard you have identified?



"What is the chance that I will trip on my tools if I leave them lying around?"



Likelihood & Severity

Given the potential negative outcome, we often look at risk as being the combination of likelihood and severity.

In other words: "How likely is it that I will fall over my tools?" and "If I do fall over them, then what harm will I come to? Will I suffer major injuries or even be killed?"

So, you need to assess how likely it is that someone can be harmed by how you carry out your work.

And the severity. Could it cause minor cuts and bruises or serious injury?



Agreement - Appendix B

This is the risk rating from the agreement. It shows how severity and likelihood are measured.

Control Measures Or Mitigation



You then put in place control measures which include actions that can be taken to reduce the potential of exposure to the hazard, remove the hazard or reduce the likelihood of the risk of the exposure to that hazard being realised.



Going back to the example of tripping over your tools, you may decide that the most suitable control measure is for everyone to put their tools back in one bucket once finished using.

Things to think about



Things to think about

Working near the highway can be hazardous due to the environment.

There are many things to think about, some of which we will go through today. However this is not exhaustive.

- Live traffic
- Working close to the public
- Lifting operations
- Hand Tools
- Holes & Height

- Falls and falling objects
- Working close to
 - water
- Dangerous substances

- First Aid
- Visibility



Live traffic

You will be working near a live highway. It is important you are aware of your surroundings.

What could happen if you accidently step off the pavement in live traffic?

Traffic swerving to avoid something could mount the pavement causing an accident.

What is the safest place to cross the road?

What time in the day is it best to carry out weed maintenance?

Ensure you know the width of the pavement. There should be no need to walk backwards.

Don't leave anything which could fall into the road and do not stand in the road.

Agree a crossing point between all volunteers.

Perhaps after the work/school run and not in the dark.



Working close to the public

The pavement will be open to be used by the general public. Consideration must be given to this.

What could happen if you leave your tools around?

Could you force a member of the public into the road due to where you are working?

Although it may be easier to leave arisings where they are until the end of the day, if you leave it on the footway it will become a trip hazard?

A passing resident or fellow volunteer could trip and injure themselves.

Stop work whenever a member of the public approaches.

Sweep and bag any removed weeds on a regular basis



Hand tools

You are only permitted to use hand tools. No powered tools.

How appropriate are the tools your using?

Old, wobbly, screws missing hand tools may not be the most appropriate.

Should you ever leave your tools unmonitored?

No. Always ensure volunteers are keeping tools tidy. Never leave tools alone.

Where should tools be kept whilst working?

Volunteers could agree a monitored area to keep all tools together.



First Aid (Health)

It is important to know what to do next if the unthinkable happens.

Do you know where your nearest hospital is?

Do you know what number to call?

Do your volunteers know where to find a first aid kit?

Are you aware of any allergies or medical needs your volunteers may have?

Its important to know where this is and how you would get there.

999 for emergencies & 111 for nonemergencies

Can be handy in many situations.

For example, a volunteer may have an allergic reaction to a plant.



Safety

Are there enough volunteers to ensure no one is working alone?

No one should be undertaking weed maintenance by themselves.

Has your group taken the necessary action to protect themselves?

Gloves, goggles, sun protection.
