Top up to the 2026/27 Crisis and Resilience Fund to support low-income heating oil households

Dear Leader,

Today, the Prime Minister announced targeted support for low-income heating oil households who are being impacted by the spike in costs. An additional £53 million of financial support will be allocated across the nations of the UK, accounting for the distribution of households reliant on heating oil across the country. In England, £27 million funding will be delivered via the Crisis and Resilience Fund to areas that have higher rates of heating oil, such as rural communities.

The government has identified your local authority as one of these areas and you will be a recipient of this additional funding. We know that there are vulnerable people facing immediate financial hardship because of the increase in heating oil prices, with the risk of losing immediate access to heating or hot water. We therefore expect that, from today, funding should be made available to those in acute need should you receive requests for support. You will receive funding next financial year as part of your Crisis and Resilience Fund payment, delivered through the 2026/27 Local Government Finance Settlement. Allocations are set out in Annex A.

The Crisis and Resilience Fund can provide help for exactly this kind of issue: to help vulnerable households facing financial difficulties as a result of a sudden unexpected expense, in line with guidance published by the Department for Work and Pensions. There will not be additional conditions placed on this funding, and we will not require any additional reporting on how it has been spent.

The Department for Work and Pensions will make a small amendment to the scheme guidance to reflect that support can be provided to households in crisis due to the increase in heating oil prices. Authorities should consider the likely effects of the spike in heating oil costs on their residents, including the types of residents that will be most affected. In these cases, local authorities should consider whether residents would be eligible for Crisis Payments. This could be via application processes, or through targeted support if it is known which residents are likely to be in crisis.

We recognise the operational challenges of this and appreciate the work that you do to help your residents in crisis. We hope that confirmation of this funding in 2026/27 will give you the certainty you need to continue this vital work and the confidence to help impacted residents immediately. We know that we are united in our wish to provide vulnerable people with the financial support they need.

At present, fuel forecourt levels remain above the average stock threshold, 40% across England. DESNZ are continuing to engage with industry to ensure supply and pricing for oil prices remains resilient.
