

### ROAD TRAFFIC REGULATION ACT 1984

#### The East Sussex (C345 Church Road, Catsfield) (30 mph Speed Limit) Order 201\*

**Notice** is hereby given that East Sussex County Council propose to make an Order under Section 84 (1) and (2) of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, which will extend the 30 mph speed limit on the following length of road:-

#### 30 mph Speed Limit

**Church Road** from a point 38 metres east of the eastern wall of Catsfield Church of England primary school, south eastwards for a distance of 270 metres.




