# The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1 (Amendment No \*) 202\*(Port Access Road, Newhaven)

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- (a) This Order may be cited as "The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No. 1 (Amendment No \*) 202\* (Port Access Road, Newhaven) and shall come into effect on XXXX 202x.
  - (b) The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1, as amended, shall have effect except as hereinafter contained:

### (i) Schedule 1, Part A, Prohibition of Waiting At Any Time, that this Schedule be amended as follows:

1. In the list of restrictions for Newhaven, the following items shall be removed as follows;

U5302 McKinlay Way (north-south section)	east side	from the roundabout junction with A259 The Drove / Drove Road (B&Q Roundabout) southwards for a distance of 650 metres
	west side	from a point 50 metres north of the junction with McKinlay Way (east-west section) southwards for a distance of 470 metres

2. In the list of restrictions for Newhaven, the following items shall be added as follows;

U5302 McKinlay Way (north-south section)	east side	from the roundabout junction with A259 The Drove / Drove Road (B&Q Roundabout) southwards for its entire length

## The East Sussex (U5302 McKinlay Way, Newhaven) (30 mph Speed Limit) Order 202\*

East Sussex County Council, in exercise of its powers under Section 84 (1) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and Traffic Management Act 2004, hereby make the following Order:-

- 1. No person shall drive any vehicle at a speed exceeding 30 mph on those lengths of road specified in the Schedule to this Order.
- 2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- 3. The East Sussex (U5302 McKinlay Way, Newhaven) (30 mph Speed Limit) Order 2018 is hereby revoked in its entirety.
- 4. This Order may be cited as "The East Sussex (U5302 McKinlay Way, Newhaven) (30 mph Speed Limit) Order 202\*" and shall come into operation on....... 202\*.
